TEMPORARY RAMP (SPECIAL)

<u>Description</u>. This work shall consist of the construction and removal of temporary HMA ramps.

The ramps shall be constructed at all driveway entrances immediately upon completion of the milling operation and when the drop-off is greater than 2.5 in. (64mm). Ramps shall be 2 in. (51mm) in height by 24 in. (600mm) in width along the full width of the driveway. Work shall be to the satisfaction of the Engineer.

The contractor shall use HMA according to Section 406 of the Standard Specifications, and other applicable HMA special provisions as contained herein. The HMA mixtures to be used shall be specified in the plans.

The temporary ramps shall be removed just prior to placing the proposed binder course.

<u>Method of Measurement.</u> Temporary Ramp (Special) will be measured for payment in place and the area computed in square yards (square meters).

<u>Basis of Payment</u>. Temporary Ramp (Special) will be paid for at the contract unit price per square yard (square meter) for TEMPORARY RAMP (SPECIAL)

BITUMINOUS MATERIALS COST ADJUSTMENTS (BDE)

Effective: November 2, 2006 Revised: August 1, 2017

Description. Bituminous material cost adjustments will be made to provide additional compensation to the Contractor, or credit to the Department, for fluctuations in the cost of bituminous materials when optioned by the Contractor. The bidder shall indicate with their bid whether or not this special provision will be part of the contract.

The adjustments shall apply to permanent and temporary hot-mix asphalt (HMA) mixtures, bituminous surface treatments (cover and seal coats), and preventative maintenance type surface treatments that are part of the original proposed construction, or added as extra work and paid for by agreed unit prices. The adjustments shall not apply to bituminous prime coats, tack coats, crack filling/sealing, joint filling/sealing, or extra work paid for at a lump sum price or by force account.
