## SPECIAL PROVISIONS

The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction", Adopted January 1, 2022, the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways", and the "Manual of Test Procedures of Materials" in effect on the date of invitation of bids, and the "Supplemental Specifications and Recurring Special Provisions" indicated on the Check Sheet included here in which apply to and govern the construction of Detroit Avenue, Section 20-00130-00-RS, in Tazewell County, and in case of conflict with any part, or parts, of said Specifications, the said Special Provisions shall take precedence and shall govern.

### **DESCRIPTION OF PROJECT**

The Detroit Avenue project consists of resurfacing Detroit Avenue from 0.7 miles north of Birchwood Street to Main Street and the construction of a multi-use path along the west side of Detroit Avenue from Birchwood Street to 0.7 miles north Birchwood Street. Improvements include sidewalk, multi-use trail, pedestrian signals, HMA pavement surface removal and overlay and all incidental items shown in the plans and as described in these Special Provisions.

### **DATE OF COMPLETION (PLUS WORKING DAYS)**

The Contractor shall schedule his operations so as to complete all work, except as specified below, and open all the roadway to traffic on or before **November 14, 2025**. The Contractor will be allowed **5** working days, after the **November 14, 2025** completion date, to complete punchlist and **cleanup**.
