
TYPICAL SECTIONS OF TRANSITIONS OF SLOPES AND **INCIDENTAL GRADING**





TRANSITION GRADING

TRANSITION GRADING BETWEEN CUT AND FILL SLOPES AND BETWEEN CUT SLOPES AND NATURAL GROUND WILL BE REQUIRED ON THIS IMPROVEMENT. THE TRANSITION SHALL BE ROUNDED AND STREAMLINED IN ORDER TO BLEND THE CUT SLOPES AND THE FILL SLOPES INTO EACH OTHER AND INTO THE ADJACENT TERRAIN. THE SLOPES AS SHOWN ON THE CROSS SECTIONS IN THESE PLANS MAY BE VARIED SOMEWHAT IN THE TRANSITION AREAS AS DIRECTED BY THE ENGINEER IN ORDER TO MEET THIS GRADING REQUIREMENT, THE QUANTITIES OF EARTH EXCAVATION INVOLVED ARE INCLUDED IN THE BALANCE QUANTITIES SHOWN ON THE PLANS AND NO OTHER COMPENSATION



GENERAL NOTES


IN GENERAL, ALL EARTH SURFACES DISTURBED DURING CON-STRUCTION OPERATIONS SHALL BE SEEDED AND MULCHED UPON COMPLETION OF ALL GRADING OPERATIONS.

FERTILIZER NUTRIENTS AND LIMESTONE SHALL BE APPLIED TO ALL SEEDED AREAS.

THE RATES OF APPLICATION OF FERTILIZER, MULCH AND LIME-STONE SHALL BE AS SPECIFIED IN THE SPECIAL PROVISIONS.

SECTIONS 250 AND 251 OF THE STANDARD SPECIFICATIONS SHALL GOVERN THIS WORK EXCEPT AS SPECIFIED HEREIN OR AS NOTED IN THE SPECIAL PROVISIONS.
