## **SITE ACCESS**

Access to the project site from the east side of the DuPage River will be allowed off of Washington Street through the DuPage Sports Complex as shown on the map below utilizing an existing concrete driveway at Washington Street.



The exact location of the route will be marked by the Engineer, in consultation with the Contractor, at the time when access will be required. Restoration of any disturbed ground with seed will be paid for separately. Should it be necessary to utilize portions of the existing trail, permission will be required from the Engineer. Any damage to the trail will be repaired by the contractor and will be paid for at the contract unit price for the associated hot-mix asphalt, aggregate, sidewalk removal and associated pay items that are needed to repair the path.
