

THE CONTRACTOR SHALL CONTACT THE DISTRICT ONE TRAFFIC CONTROL SUPERVISOR AT (847) 705-4470 FOR ARTERIALS AND (847) 705-4151 FOR EXPRESSWAY A MINIMUM OF 72 HOURS IN ADVANCE OF BEGINING WORK.

CONTRACTOR SHALL REQUEST AND GAIN THE APPROVAL FROM THE ILLINOIS DEPARTMENT OF TRANSPORTATION'S EXPRESSWAY TRAFFIC OPERATIONS ENGINEER AT www.idotics.com TWENTY-FOUR (24) HOURS IN ADVANCE OF ALL DAILY LANE, RAMP AND SHOULDER CLOSURES.

PLAN DIMENSIONS AND DETAILS RELATIVE TO EXISTING PLANS ARE SUBJECT TO NOMINAL CONSTRUCTION VARIATIONS. THE CONTRACTOR SHALL FIELD VERIFY EXISTING DIMENSIONS AND DETAILS AFFECTING NEW CONSTRUCTION AND MAKE NECESSARY APPROVED ADJUSTMENTS PRIOR TO CONSTRUCTION OR ORDERING OF MATERIALS. SB I-57 AT IL. RTE 50 (CICERO AVE) HAS 4 LANES UNDER THE IL. RTE 50 (CICERO AVE) BRIDGE, CONTRACTOR MAY ONLY CLOSE THE RIGHT TWO LANES UNDER THIS BRIDGE IN THE SOUTHBOUND DIRECTION. THE CONTRACTOR MAY ONLY CLOSE A SINGLE RIGHT IN THE NORTHBOUND DIRECTION.

I-80 TO I-57 EXIT ARE FREEWAY TO FREEWAY (SYSTEM INTERCHANGE) FULL RAMPS AND SHALL ALLOWABLE HOURS FOR SAID RAMPS. PLEASE SEE THE KEOTT CONTRACT SPECIAL PROVISIONS FOR ALLOWABLE HOURS.

THE COLOR OF THE FINAL FINISH COAT FOR ALL INTERIOR STEEL SURFACES SHALL BE GRAY, MUNSELL NO 5B 7/1. THE COLOR OF THE FINAL FINISH COAT FOR THE EXTERIOR AND BOTTOM FLANGE OF THE FASCIA BEAMS SHALL BE REDDISH BROWN, MUNSELL

ALL ITEMS (SUCH AS. BUT NOT LIMITED TO: CONDUITS, BRACKETS AND DECK DRAINS) ATTACHED TO OUTSIDE OF THE FASCIA BEAMS SHOULD BE CLEANED AND PAINTED

A MINIMUM OF TWO (2) AIR MONITORS WILL BE REQUIRED TO MONITOR ABRASIVE BLASTING OPERATIONS. SEE SPECIAL PROVISIONS FOR "CONTAINMENT AND DISPOSAL OF LEAD PAINT CLEANING RESIDUES.
