In accordance with the Project Labor Agreement Act (30 ILCS 571), it is recommended that a project labor agreement (PLA) be utilized for the above-captioned Project. This recommendation is based on the considerations indicated below.

\_\_\_\_\_ 1) The Project is being awarded and administered by IDOT (i.e., not by another governmental agency).

 $\underline{[X]}$  2) The Project is being constructed using state or local funds only (i.e., no federal funds).

[X] 3) The overall size, scope, sequencing, logistics or other aspects of the Project make it particularly challenging to manage, and use of a PLA is expected to help assure that the construction work is performed properly and efficiently under the circumstances.

 $\underline{[X]}$  4) The duration of construction activity on the Project is expected to exceed one construction season (i.e., 110 or more working days), or the nature of the Project results in a heightened need for labor force continuity and stability over a substantial period of time.

\_\_\_\_\_\_5) There is a firm construction completion date established for the Project thereby increasing the adverse consequences of any work stoppage or other labor disruption. {See Attachment A}

 $\underline{[X]}_{6}$  The time required to complete the Project is expected to extend beyond the expiration date of one or more existing collective bargaining agreements covering trades likely to be involved in the Project, thereby increasing the likelihood of work stoppage(s) or other labor disruption(s) during construction of the Project.

The use of a Project Labor Agreement for Contract 60W01 is consistent with all State and Local statutory and regulatory requirements.

Item 3: Estimated project cost is \$21,000,000

Any disruption in the continuity of this project due to labor issues would result in delayed deadlines that would cause safety concerns for the travelling public. Lapsing trade contracts during the project would be addressed through the use of a Project Labor Agreement. It is the Illinois Department of Transportation's finding that the large skilled workforce needed for this project can be provided by the union trades involved and is a necessary requirement for a Project Labor Agreement.

**Item 5**: Contract completion date is September 12, 2014. The work shall be done in five stages narrowing Irving Park Road down to one lane in each direction for the majority of construction. Stage One will have traffic in the inside lanes. Stage Two will shift traffic to the outside lanes. Stage Three will shift all traffic to the north side of Irving Park Road. Stage Four will shift all traffic to the south side of Irving Park Road. Stage Five will have two lanes going in the eastbound direction and one lane and corresponding turn lanes in the westbound direction.

**Item 8**: This project is located near O'Hare airport. There is a lot of freight carrier traffic along Irving Park Road. Should a strike of any kind occur which results in a work stoppage, it would cause further impacts to the freight carriers making deliveries to and from the airport. Also, the motorists would be required to drive through the construction zone for a longer period of time than what is planned in the contract. While we use all the current standards and devices for our maintenance of traffic, the work zone can be a dangerous place for drivers. Therefore, use of a PLA will ensure we complete the job in a timely manner, the safest for all motorists who travel this route.
