


## SECTION B-B


1 Splicing Flanges shall be attached to each truss unit with the truss shop assembled to camber shown. Truss units shall be in proper alignment and flange surfaces shall be shop bolted into full contact before weiding. Sufficient external welds or tacks shall be made to secure flanges until remaining welds are made after disassembly. Adjacent flanges shall be "match marked" to insure proper field assembly.



Note:

Units shall be shipped individually with adequate provision to prevent detrimental motion during transport. This may require ropes between horizontals and diagonals or energy dissipating (elastic) ties to the vehicle. The Contractor is responsible for maintaining the configuration and protection of the units.

# CAMBER DIAGRAM Camber curve shown is theoretical. Actual camber


Camber curve shown is theoretical. Actual cambe attained by slope changes at splices between units.

(Lower Chord - all panel points)


(Upper Chord - each end of each unit only)
