## MAINTENANCE OF TRAFFIC GENERAL NOTES

1. THE CONTRACTOR SHALL OBTAIN WRITTEN APPROVAL OF THE ENGINEER PRIOR TO MAKING ANY CHANGES TO THE MAINTENANCE OF TRAFFIC AND STAGING PLANS.

2. THE CONTRACTOR SHALL BE RESPONSIBLE TO COORDINATE ANY ROAD OR SIGNIFICANT DRIVEWAY CLOSURES AND DETOURS AT LEAST 72 HOURS IN ADVANCE WITH ALL MUNICIPALITIES, EMERGENCY SERVICES, SCHOOL DISTRICTS AND

3. THE CONTRACTOR SHALL MAINTAIN ACCESS TO ALL DRIVEWAYS AND SIDEROADS ALONG THE PROJECT CORRIDOR DURING CONSTRUCTION. TEMPORARY ACCESS ITEMS HAVE BEEN INCLUDED TO MAINTAIN ACCESS. HAM SURFACE COURSE, MIX D, N5O HAS BEEN INCLUDED TO BE USED AS DIRECTED BY THE ENGINEER TO PROVIDE SURFACE ON THE "TEMPORARY ACCESS (ROAD)" ITEM WHEN NEEDED.

4. TYPE I OR II BARRICADES AND VERTICAL PANELS SHALL BE EQUIPPED WITH MONO-DIRECTIONAL STEADY BURN LIGHTS AND SHALL BE PLACED AT 50 FOOT INTERVALS ALONG THE PROPOSED WORK ZONE, 25 FOOT INTERVALS BECTIONS, AND 10 FOOT INTERVALS AROUND RADII AS SHOWN ON THE PLANS OR AS DIRECTED BY THE ENGINEER. BARRICADES WITH LEG EXTSIONS SHALL BE USED WHERE NEEDED TO PROVIDE A MINIMUM DISTANCE OF 36" BETWEEN THE PAVEMENT AND TOP OF BARRICADE; BARRICADES IN TAPER SECTIONS SHALL HAVE DIRECTION INDICATOR PANELS.

5. SIDEROAD CLOSURES AND DETOURS AS ALLOWED IN THE PLANS SHALL BE LIMITED TO A MAXIMUM OF 28 DAYS PER INTERSECTION. DURING THE CLOSURE THE US 30 MAINLINE PAVMENT ADJACENT TO THE SIDEROAD SHALL BE CONSTRUCTED IN A CONTINUOUS POUR AND THE CLOSED ROADWAY CONSTRUCTED. NO ADDITIONAL CLOSURES WILL BE ALLOWED ON THE SIDEROAD WITHOUT THE APPROVAL OF THE ENGINEER.

6. THE CONTRACTOR SHALL MAINTAIN DRAINAGE OF THE ROADWAY DURING ALL STAGES OF CONSTRUCTION. TEMPORARY DRAINAGE ITEMS HAVE BEEN INCLUDED IN THE PLANS TO ASSIST IN TEMPORARY DRAINAGE. THE CONTRACTOR SHALL MAINTAIN AND INSTALL ADDITIONAL DRAINAGE ITEMS AS REQUIRED AND APPROVED BY THE ENGINEER TO ASSURE THE SAFE OPERATION OF THE TRAVELING PUBLIC.

7. THE CONTRACTOR SHALL REMOVE ALL EXISTING PAVEMENT MARKINGS IN CONFLICT WITH MARKINGS NEEDED TO MAINTAIN TRAFFIC AS INCLUDED IN THE PLANS OR AS DIRECTED BY THE ENGINEER.

8. ANY ADDITIONAL LANE CLOSURES REQUIRED SHALL BE APPROVED IN ADVANCE BY THE ENGINEER.

9. TEMPORARY PAVEMENT MARKINGS SHALL BE WET TEMPORARY PAVEMENT MARKING TAPE TYPE III.

10. PORTABLE CHANGEABLE MESSAGE SIGNS SHALL BE PLACED AND MESSAGES DISPLAYED AS DIRECTED BY THE ENGINEER.

11. PERMANENT DRAINAGE STRUCTURES INSTALLED IN EARLY STAGES OF CONSTRUCTION THAT ARE TO BE USED FOR TEMPORARY DRAINAGE OR ARE IN CONFLICT WITH SUBSEQUENT STAGES OF CONSTRUCTION WILL BE FABRICATED SO THEY CAN BE INSTALLED INITIALLY TO GRADES NEEDED FOR TEMPORARY DRAINAGE OR TO BE LOW ENOUGH TO NOT BE A HAZARD TO THE TRAVELING PUBLIC DURING STAGED TRAFFIC. THE COST OF MODIFYING THE STRUCTURE TO COMPLETE IT AT FINAL GRADE WITH ITS FINAL FRAME AND PROVIDING THE TYPE 8 FRAME FOR DRAINAGE DURING STAGE CONSTRUCTION SHALL BE PAID AS TYPE OF STRUCTURE "TO BE ADJUSTED (SPECIAL)".

12. EXISTING STRUCTURES TO REMAIN THROUGHOUT CONSTRUCTION SHALL BE PLATED TO BE ADJUSTED TO FINAL GRADE WHEN THE PAVEMENT IS INSTALLED ANY DEBRIS IN THE STRUCTURE SHALL BE REMOVED AS REQUIRED BY THE ENGINEER. THIS WORK WILL BE INCLUDED IN THE COST OF THE ADJUSTMENT PAY ITEM FOR

13. THE CONTRACTOR SHALL COORDINATE THIS STAGING WITH THE CONTRACTOR OF CONTRACT #62478 TO THE EAST AND OTHER ADJACENT PROJECTS IN THE AREA.

14. TEMPORARY SIGNALS SHALL BE OPERATIONAL PRIOR TO ADJUSTING TRAFFIC PATTERNS.

15. THE CONTRACTOR SHALL BE REQUIRED TO RELOCATE OR TO REMOVE AND REPLACE ALL ROAD SIGNS WHICH INTERFERE WITH CONSTRUCTION OPERATIONS AND TO TEMPORARILY RESET ALL SIGNS DURING CONSTRUCTION.
ALL WORK INVOLVING SIGNS SHALL BE GOVERNED BY THE FOLLOWING REQUIREMENTS:

A, SIGNS SHALL NOT BE MOVED UNTIL PROGRESS OF WORK DEMANDS.
B, EVERY SIGN REMOVED MUST BE RE-ERECTED AT THE TEMPORARY LOCATION
IN A WORKMANLIKE MANNER AND BE VISIBLE TO TRAFFIC. ALL SUCH SIGNS MUST
BE MAINTAINED STRAIGHT AND NEAT FOR THE DURATION OF THE TEMPORARY SETTING.
C, ALL PAVEMENT MARKINGS PROPOSED WITHIN A GIVEN WORK ZONE AREA SHALL
BE COMPLETED PRIOR TO CONSTRUCTION PHASE CHANGE.

16. DRAINAGE STRUCTURES NOT CONNECTED TO AN OUTLET SEWER SHALL BE COVERED AND LATERALS TEMPORARILY PLUGGED UNTIL THE CONNECTION IS MADE IN A LATER STAGE.

17. THE CONTRACTOR SHALL PROVIDE ALL SIGNS, VERTICAL PANELS, TYPE II BARRICADES/OR DRUMS, TEMPORARY CONCRETE BARRIER AND ALL OTHER TRAFFIC CONTROL DEVICES NECESSARY FOR THE MAINTENANCE OF TRAFFIC, OR AS DIRECTED BY THE ENGINEER.
