


GENTLY REMOVE CONTAINER BEFORE PLANTING, KEEPING ROOT SYSTEM INTACT MULCH, 4" NUGGET BARK (1"-3" SIZE) FOR PERENNIALS/GROUNDCOVER DO NOT COVER CROWNS TOPSOIL FURNISH AND PLACE, SPECIAL 12" DEPTH. SEE SPECIFICATIONS AND SPECIAL PROVISIONS FOR DETAILS

PERENNIAL/GROUNDCOVER PLANTING DETAIL

NOTE: PRUNING SHALL NOT CHANGE THE HABIT OF THE TREE. ALL CUTS SHALL BE MADE JUST OUTSIDE THE BRANCH BARK RIDGE AND COLLAR, ANGLING AWAY FROM THE STEM, PRUNING SHALL BE LIMITED TO THE REMOVAL OF COMPETING LEADERS, OR DEAD, RUBBING, BROKEN OR DAMAGED BRANCHES AND ONLY AT THE DIRECTION OF THE R.E.
