


THE DEPARTMENT MAY REMOVE AND NOT INSTALL MARKERS IN CERTAIN LOCATIONS AT THE ENGINEER'S DISCRETION.

THE DEPARTMENT MAY INSTALL MARKERS IN CERTAIN LOCATIONS THAT DID NOT PREVIOUSLY HAVE MARKERS AT THE ENGINEER'S DISCRETION.

THE LOCATIONS OF THE REPAIR AREAS SHALL BE DETERMINED BY THE ENGINEER.

THE WORK SITE SHALL BE LEFT IN A SAFE AND ORDERLY CONDITION, FILLING ANY HOLES CREATED BY THE END OF THE WORK DAY.

NO MATERIAL SHOULD BE LEFT ON OR NEAR THE ROADWAY.

REMOVAL OF DAMAGED MATERIALS WILL INCLUDE LOADING, HAULING, AND DISPOSAL.

ANY NECESSARY TRAFFIC CONTROL WILL BE PROVIDED BY THE CONTRACTOR; APPROPRIATE STANDARDS ARE LISTED ON SHEET NO. 2. TRAFFIC CONTROL SHALL NOT BE PAID FOR AS SEPARATE PAY ITEMS, BUT SHALL BE CONSIDERED A PART OF THE CONTRACT.

THE QUANTITIES SPECIFIC IN THIS CONTRACT ARE ONLY AN ESTIMATE TO ALLOW CONTRACTORS TO ESTABLISH UNIT PRICES AND PERMIT THE DEPARTMENT TO DETERMINE THE LOW BIDDER. IT SHALL BE UNDERSTOOD THAT THE UNIT PRICES OF THIS CONTRACT SHALL PREVAIL THROUGHOUT THE CONTRACT REGARDLESS OF THE QUANTITY.
