



#### GENERAL BRIDGE NOTES

- 1. THE CONTRACTOR SHALL TAKE NECESSARY PRECAUTIONS TO INSURE THAT NO DEBRIS WILL ENDANGER OR INTERFERE WITH TRAFFIC ON THE ROADWAY (OR THE RAILROAD) BENEATH THE BRIDGE ACCORDING TO ARTICLE 107.09 (OR 107.12) OF THE STANDARD SPECIFICATIONS. THIS WORK WILL NOT BE PAID FOR SEPARATELY, BUT SHALL BE INCLUDED IN THE CONTRACT UNIT PRICE FOR THE APPROPRIATE PAY ITEM INVOLVED AND NO ADDITIONAL COMPENSATION WILL BE ALLOWED.
- 2. PLAN DIMENSIONS AND DETAILS RELATIVE TO EXISTING PLANS ARE SUBJECT TO NOMINAL CONSTRUCTION VARIATIONS. THE CONTRACTOR SHALL FIELD VERIFY EXISTING DIMENSIONS AND DETAILS AFFECTING NEW CONSTRUCTION AND MAKE NECESSARY APPROVED ADJUSTMENTS PRIOR TO CONSTRUCTION OR ORDERING OF MATERIALS. SUCH VARIATIONS SHALL NOT BE CAUSE FOR ADDITIONAL COMPENSATION FOR A CHANGE IN SCOPE OF THE WORK, HOWEVER, THE CONTRACTOR WILL BE PAID FOR THE QUANTITY ACTUALLY FURNISHED BASED AT THE UNIT PRICE BID FOR THE WORK.
- 3. STRUCTURE SHEETS "GENERAL PLAN AND ELEVATION", "DRAINAGE PLAN" AND "DRAINAGE PLAN AND DETAILS" CREATED FROM ORIGINAL AS- BUILT DRAWINGS. THESE ARE PROVIDED FOR GENERAL REFERENCE TO STRUCTURE NUMBER, SPAN NUMBER AND LENGTH, ETC. WORK ITEMS FOR THIS CONTRACT ARE IDENTIFIED ON THE PLAN AND DETAIL SHEETS THAT FOLLOW.
- 4. THE LOCATIONS SHOWN AS REQUIRING DRAINAGE REPAIRS IDENTIFY THE GENERAL DEFICIENCY AND PROVIDE AN ESTIMATED LENGTH OF NEW PIPE REQUIRED. THE DRAINAGE SYSTEM IS SHOWN SCHEMATICALLY. IT SHALL BE THE CONTRACTORS RESPONSIBILITY TO VERIFY THE LOCATIONS, DIMENSIONS AND DETAILS PRIOR TO ORDERING THE MATERIAL. SUCH VARIATIONS SHALL NOT BE CAUSE FOR ADDITIONAL COMPENSATION FOR A CHANGE IN THE SCOPE OF WORK, HOWEVER THE CONTRACTOR WILL BE PAID FOR THE QUANTITY ACTUALLY FURNISHED AT THE UNIT PRICE BID FOR THE WORK.
- 5. THE CONTRACTOR SHALL PROVIDE ALL PIPING, BRACKETS, HANGERS, FITTINGS, HARDWARE, CLAMPS AND OTHER ACCESSORIES REQUIRED TO RETURN THE EXISTING DRAINAGE SYSTEM TO A FULLY FUNCTIONAL LEAK FREE SYSTEM. SEE SPECIAL PROVISIONS.
- 6. WHEN EXISTING DRAIN PIPES ARE WRAPPED WITH TAPE, THE TAPE SHALL BE REMOVED IF PIPE IS BROKEN OR MISSING CONNECTION. THE PIPE SHALL BE REPLACED OR OTHERWISE NEW TAPE SHALL BE PROVIDED. THE TYPE OF THE TAPE SHALL BE APPROVED BY THE ENGINEER. THE COST SHALL BE INCLUDED IN "BRIDGE DRAINAGE SYSTEM REPAIRS" AND THE LENGTH MEASURED SHALL BE LENGTH OF THE PIPE REPLACED OR THE LENGTH OF PIPE RE- TAPED.
- 7. THE CONTRACTOR SHALL WRAP ANY JOINTS THAT ARE LEAKING AS DIRECTED BY THE ENGINEER. THE COST SHALL BE INCLUDED IN "BRIDGE DRAINAGE SYSTEM REPAIRS".

#### **GENERAL NOTES**

- 1. BEFORE STARTING ANY EXCAVATION IN THE CITY OF CHICAGO, THE CONTRACTOR SHALL CALL "C.U.A.N." (CHICAGO UTILITY ALERT NETWORK) AT (312)744-7000 FOR FIELD LOCATIONS OF BURIED ELECTRIC, TELEPHONE AND GAS UTILITIES. (48 HOUR NOTIFICATION IS REQUIRED).
- 2. THE CONTRACTOR SHALL COORDINATE CONSTRUCTION ACTIVITIES WITH UTILITY COMPANIES. CITY OF CHICAGO
- 3. THE CONTRACTOR WILL NOT BE ALLOWED TO SET UP A YARD OR FIELD OFFICE ON STATE PROPERTY WITHOUT WRITTEN PERMISSION FROM THE DEPARTMENT.
- 4.IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO VERIFY ALL DIMENSIONS AND CONDITIONS EXISTING IN THE FIELD PRIOR TO CONSTRUCTION AND ORDERING OF MATERIALS.
- 5. THE CONTRACTOR SHALL CONTACT THE DISTRICT ONE TRAFFIC CONTROL SUPERVISOR AT (847)705-4470 FOR ARTERIALS AND (847)705-4151 FOR EXPRESSWAYS A MINIMUM OF 72 HOURS IN ADVANCE OF BEGINNING WORK.
- 6. THESE PLANS HAVE BEEN PREPARED FROM NOTES RECEIVED FROM THE BUREAU OF MAINTENANCE BRIDGE INSPECTORS.
- 7. DO NOT SCALE PLANS FOR CONSTRUCTION DIMENSIONS.
- 8. THE CONTRACTOR SHALL BE REQUIRED TO PROVIDE ACCESS TO ABUTTING PROPERTY AT ALL TIMES DURING THE CONSTRUCTION OF THIS PROJECT.
- 9. THE CONTRACTOR IS ADVISED THAT THERE WILL BE OTHER WORK OCCURING ON THE EXPRESSWAY SYSTEM AT THE TIME OF THIS CONTRACT. THE CONTRACTOR WILL BE REQUIRED TO ATTEND WEEKLY COORDINATION MEETING TO SCHEDULE NIGHT TIME EXPRESSWAY LANE CLOSURES.




### DETAIL (TYPCIAL CONNECTION OF DOWNSPOUT TO I-90/94 DRAINAGE)








