## **GUARDRAIL POST REPAIR**

This work shall be done in accordance with Sections 630, 631, 632, 633, and 701.17(f) of the Standard Specifications and as specified herein.

<u>Description.</u> When the guardrail post has been damaged, the Contractor shall remove and replace the steel post and wood blockout. When the condition of the guardrail post is still usable, the Contractor may replace the wood blockout in lieu of replacing the entire post. The Engineer will make the determination of the condition of the existing post.

<u>Method of Measurement.</u> This work will be measured for payment, complete in place, in units of each for each post and/or blockout replaced.

Basis of Payment. This work will be paid for at the contract unit price per each for GUARDRAIL POST REPAIR
