

- The Contractor shall drive (1) test pile, as specified in a permanent location as directed by the Engineer before ordering the remaining piles.
- 2. See Special Provisions for boring logs.
- All exposed portions of the structural steel & sheet piling shall be painted in accordance with the applicable portions of section 506 of the Standard Specifications and the Special Provisions. Color shall be reddish brown.

I certify that to the best of my knowledge, information and belief, this bridge design is structurally adequate for the design loading shown on the plans. The design is an economical one for the style of structure and complies with the requirements of the current "AASHTO Standard Specifications for Highway Bridges."
