- 2. THE CONTRACTOR SHALL VERIFY ALL DIMENSIONS AND CONDITIONS IN THE FIELD PRIOR TO CONSTRUCTION AND ORDERING MATERIALS.
- 3. ILLINOIS STATE LAW REQUIRES A 48-HOUR NOTICE BE GIVEN TO ALL UTILITIES BEFORE DIGGING. FIELD MARKING OF FACILITIES MAY BE OBTAINED BY CONTACTING JULLIE. OR FOR NON-MEMBERS, THE UTILITY COMPANY DIRECTLY. AGENCIES KNOWN TO HAVE FACILITIES WITHIN THE PROJECT AREA ARE AS FOLLOWS:

- 4. ANY AREAS DISTURBED BY THE CONTRACTOR'S OPERATIONS SHALL BE SEEDED ACCORDING TO IDOT POLICY AS SOON AS POSSIBLE. THIS WORK WILL NOT BE MEASURED FOR PAYMENT BUT SHALL BE CONSIDERED AS INCLUDED IN THE COST OF THE CONTRACT.
- 5. "ROAD CONSTRUCTION AHEAD" SIGNS SHALL BE PLACED AT EACH END OF THE PROJECT AND ALL INTERSECTING SIDE ROADS AND WILL BE INCLUDED IN THE TRAFFIC CONTROL PAY ITEMS, ALL CONSTRUCTION SIGNS SHALL BE FLORESCENT ORANGE IN COLOR, SKID MOUNTED, AND 48". NO ADDITIONAL COMPENSATION FOR THIS WILL BE ALLOWED.
- 6. THE RESIDENT ENGINEER SHALL VERIFY THE EXISTENCE OF HIGHWAY LIGHTING AND/OR I.T.S. UTILITIES WITHIN THE PROJECT LIMITS. IF HIGHWAY LIGHTING AND/OR I.T.S. EXISTS WITHIN THE PROJECT LIMITS, AND IF THESE ITEMS REQUIRE LOCATING, THE CONTRACTOR SHALL BE DIRECTED TO DO SO ACCORDING TO SECTION 803 OF THE STANDARD SPECIFICATIONS. THIS WORK SHALL BE PAID FOR ACCORDING TO ARTICLE 109.04 OF THE STANDARD SPECIFICATIONS.
- 7. THE BOTTOM 6" OF THE TEMPORARY CONCRETE BARRIER SHALL BE PAINTED WITH TEMPORARY PAYEMENT MARKING- WHITE. THIS WILL NOT BE MEASURED FOR PAYMENT BUT SHALL BE CONSIDERED AS INCLUDED IN THE COST OF TEMPORARY CONCRETE BARRIER AND NO OTHER COMPENSATION SHALL BE ALLOWED.
- 8. FOR STABILIZATION PURPOSES, ALL TYPE III BARRICADES SHALL REQUIRE A MINIMUM OF 6 SANDBAGS PER BARRICADE.
- 9. HOT-MIX ASPHALT SHOULDERS HAVE BEEN INCLUDED IN THE PLANS TO PAY FOR ANY SHOULDER DAMAGE THAT MAY OCCUR DUE TO CONSTRUCTION ACTIVITIES.


