





- 1. THE CONTRACTOR SHALL COORDINATE ALL ACTIVITIES WITH: CONTRACT 60A05 - SB FENCE AND GATES FROM 47TH PLACE TO 31ST ST CONTRACT 60A79 - GATEWAY LANDSCAPING AND IRRIGATION @ 35TH STREET CONTRACT 62303 - RECONSTRUCTION OF SOUTHBOUND LOCAL LANES AND RAMPS BETWEEN GARFIELD BOULEVARD AND 31ST CONTRACT 62583 - LIGHTING AND SURVEILLANCE 31ST ST TO I-57 INTERCHANGE
- 2. CONTRACTOR SHALL MATCH ALL WORK COMPLETED IN CONTRACT 62301
- 3. THE LOCATIONS OF EXISTING UTILITIES, AS SHOWN ON THE DRAWINGS, REPRESENT DATA RECEIVED FROM VARIOUS SOURCES. IT IS NOT GUARANTEED TO BE CORRECT OR ALL INCLUSIVE. THE CONTRACTOR MUST CONDUCT HIS OWN INVESTIGATIONS INTO THE LOCATION, SIZE, DEPTH, AND NATURE OF ANY AND ALL EXISTING UTILITIES WHICH MAY IMPACT THE WORK UNDER THIS CONTRACT, ANY EXISTING UTILITIES WHICH ARE TO REMAIN IN SERVICE MUST BE FULLY PROTECTED BY THE CONTRACTOR AND ANY DAMAGE CAUSED BY THE CONSTRUCTION MUST BE IMMEDIATELY REPAIRED AT THE CONTRACTOR'S EXPENSE TO THE SATISFACTION OF THE ENGINEER. AT (312) 744-7000 OR 811 FOR FIELD LOCATIONS OF BURIED ELECTRICAL, TELEPHONE, CABLE, AND GAS FACILITIES (48 HOURS NOTIFICATION IS REQUIRED). THE CONTRACTOR MUST CONTACT THE CITY OF CHICAGO DEPARTMENT OF WATER MANAGEMENT, PERMIT SECTION AT (312) 747-7893 FOR WATER AND CITY SEWER LOCATIONS.
- 5. THE CONTRACTOR WILL NOT BE ALLOWED TO SET UP A YARD OR FIELD OFFICE ON STATE PROPERTY WITHOUT WRITTEN PERMISSION FROM IDOT.

THE EXACT LOCATION OF THESE FACILITIES IS NOT KNOWN. THE CONTRACTOR MUST CONTACT THE CTA AT 312-681-3860 FOR LOCATIONS OF THESE FACILITIES BEFORE PROCEEDING WITH ANY WORK WITHIN OR ADJACENT TO THE CTA OPERATING AREA, FOR ADDITIONAL INFORMATION REGARDING BURIED CONDUITS, CONTACT MR. - 19. THE CONTRACTOR MUST USE CARE IN GRADING OR EXCAVATING NEAR ANY AND ALL EXISTING ITEMS THAT WILL NOT BE REMOVED. ANY DAMAGE DONE TO EXISTING ITEMS BY THE CONTRACTOR MUST BE REPAIRED BY THE CONTRACTOR AT THE CONTRACTOR'S OWN EXPENSE.
- 20. THE CONTRACTOR MUST MAINTAIN THE SURFACE DRAINAGE OF ALL ROADWAYS DURING CONSTRUCTION OF THIS PROJECT. WHEN EXISTING DRAINAGE FACILITIES ARE DISTURBED. THE CONTRACTOR MUST PROVIDE AND MAINTAIN TEMPORARY OUTLETS AND CONNECTIONS FOR ALL PRIVATE OR PUBLIC DRAINS, SEWERS, AND CATCH BASINS. THE CONTRACTOR MUST PROVIDE FACILITIES TO TAKE IN ALL STORM WATER WHICH WILL BE RECEIVED BY THESE DRAINS AND SEWERS AND DISCHARGE THE SAME. THE CONTRACTOR MUST PROVIDE AND MAINTAIN A TEMPORARY OUTLET AND BE PREPARED AT ALL TIMES TO DISPOSE OF THE WATER RECEIVED FROM THESE TEMPORARY CONNECTIONS UNTIL INSTALLATION IS COMPLETE INCLUDING PAVEMENT, THIS WORK MUST NOT BE PAID FOR SEPERATELY BUT MUST BE CONSIDERED INCLUDED IN THE COST OF THIS CONTRACT.

THE CONTRACTOR SHALL TAKE ALL NECESSARY PRECAUTIONS FOR THE PROTECTION OF EXISTING PLANT MATERIAL FOR WHICH THE CONTRACT DOES NOT PROVIDE REMOVAL, THE PROTECTION OF EXISTING PLANT MATERIAL AND THE REPAIR OR REPLACEMENT OF EXISTING PLANT MATERIAL DAMAGED BY THE CONTRACTOR SHALL BE DONE IN ACCORDANCE WITH THE REQUIREMENTS OF SECTION 201 OF THE STANDARD SPECIFICATIONS.
- 22. ALL RELOCATION OF EXISTING SIGNS IN CONFLICT WITH PROPOSED CONSTRUCTION SHALL CONFORM TO ARTICLE 107,25 OF THE STANDARD SPECIFICATIONS. EXISTING SIGNS TO BE RELOCATED IN PROPOSED CONCRETE MEDIAN SURFACE SHALL BE INSTALLED USING A SLEEVE OR BY CORING THE CONCRETE MEDIAN SURFACE. THE SLEEVE AND CORING OPERATIONS SHALL BE AS DIRECTED AND APPROVED BY THE ENGINEER. EXISTING SIGNS TO BE RELOCATED ONTO PROPOSED KNEE WALL FOOTINGS SHALL BE INSTALLED ACCORDING TO SECTIONS 728 AND 731 OF THE STANDARD SPECIFICATIONS. 
