The application of Bituminous Materials Prime Coat shall be completed according to the "Standard Specifications for Road and Bridge Construction" adopted January 1, 2007.

<u>Temporary Entrance</u>: Removal of granular material and shaping of the ground will be incidental to the cost of the granular material. Removal of 12" pipe culvert will be incidental to the cost of the pipe.

<u>Signs, Mailboxes, Obstructions:</u> Any items requiring temporary relocation to allow for proposed work shall be temporarily relocated to the satisfaction of the Engineer and permanently replaced after construction is completed. This work is to be included in the unit cost of Hot Mix Asphalt Surface Course, Mix C, N70 and no additional compensation will be allowed.
