THE CONTRACTOR SHALL COORDINATE CONSTRUCTION ACTIVITIES WITH UTILITY COMPANIES, THE CITIES OF ELGIN, GENEVA, AURORA, ST. CHARLES, BATAVIA AND THE VILLAGES OF BARTLETT, STREAMWOOD, HAMPSHIRE, NORTH AURORA AND WEST DUNDEE.

IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO VERIFY ALL DIMENSIONS & CONDITIONS EXISTING IN THE FIELD PRIOR TO CONSTRUCTION & ORDERING OF MATERIALS.
