THIS PROJECT IS LOCATED ON VARIOUS ROUTES IN FAYETTE, EFFINGHAM, JASPER, CRAWFORD, CLAY, RICHLAND, LAWRENCE, WAYNE, EDWARDS AND WABASH ALL LOCATED WITHIN REGION 4-DISTRICT 7. THE WORK INCLUDED IN THIS SECTION CONSISTS OF MAINTAINING AND REPAIRING THE ELECTRICAL SYSTEMS AND ALL OTHER WORK NECESSARY TO COMPLETE THIS SECTION.

ALL WORK IS TO BE REPLACED IN KIND OR, AS INDICATED ON THE CONTRACT PLANS OR PROVISIONS.

THE LOCATIONS OF THE REPAIR AREAS SHALL BE DETERMINED BY THE ENGINEER.

REMOVAL OF DAMAGED MATERIALS WILL INCLUDE DISMANTLING, LOADING, HAULING AND DISPOSAL. THE WORK SITE WILL BE LEFT IN A SAFE AND ORDERLY CONDITION.

NO MATERIAL SHOULD BE LEFT ON OR NEAR THE ROADWAY DURING NON-WORKING HOURS.

ANY NECESSARY TRAFFIC CONTROL WILL BE PROVIDED BY THE CONTRACTOR; APPROPRIATE STANDARDS ARE LISTED ON THIS SHEET UNDER THE INDEX OF SHEETS.

ILLINOIS STATE LAW REQUIRES A 48-HOUR NOTICE TO BE GIVEN TO UTILITIES BEFORE DIGGING. FIELD MARKING OF FACILITIES MAY BE OBTAINED BY CONTACTING J.U.L.I.E.
