COOPERATION BETWEEN CONTRACTORS

It is anticipated that this project will be constructed concurrently with other highway projects that have stage construction, lane closures, and/or interstate closures for the same area. The projects that may be under contract concurrent with this project are:

IDOT – District 8 Operations

FAI 70 (I-55/I-70) St. Clair County Miscellaneous roadway maintenance repairs on I-55/I-70 during interstate directional weekend closures.

FAI 270 (I-270) Madison County Contract number: 76K23 Patching and microsurfacing from 0.5 mi E of IL 3 (St. Thomas Rd) to 0.5 mi E of I-55/70. <u>This contract will be given highest priority as the Department exercises ultimate</u> <u>authority in determining allowable weekends for interstate closures for all concurrent</u> <u>IDOT contracts in the region.</u>

FAI 55/70/64 (I-55/I-70/I-64) Madison & St. Clair Counties Contract number: 76K13 Bridge painting on I-55/70 at 1.4 mi W of IL 157 (SN 060-0205 & SN 060-0211) and on I-64 at 1.0 mi W of IL 157 (SN 082-0261).

FAI 70 (I-70) Madison County Contract number: 76K48 Patching of I-55/70 (eastbound lanes only) at the "Skyhook Bridge", 0.7 miles west of I-255.

Various Routes St. Clair County Contract number: 76k26 Bridge deck sealing at various locations. Multiple deck sealing locations are in the vicinity of Contract 76K16.
