 Stretcher bars shall be used at all four sides of each panel.
 If the option of drilling and epoxy grouting the anchor rods is chosen, The Contractor shall use the capsule or the adhesive cartridge type anchor rods that have been previously tested and
- given a prior approval by the Department. The Contractor shall install these anchor rods in pre-drilled holes according to the manufacturer's recommendations and procedures. The capsule or the adhesive cartridge shall be sealed with pre-measured amounts of the adhesive chemical.
