- 7. PROTECTIVE COAT SHALL BE APPLIED TO ALL GUTTER FLAGS, FACE OF CURB, AND MEDIAN SURFACE.
- 8. MIXTURES FOR JOINTS, CRACKS, AND FLAGWAYS SHALL BE PAID FOR ACCORDING TO ARTICLE 109.04 OF THE STANDARD SPECIFICATIONS.
- 9. THE USE OF VIBRATORY ROLLERS IS NOT ALLOWED IN RESIDENTIAL AREAS AND IS PROHIBITED IN ALL AREAS, UNLESS IT CAN BE DETERMINED BY THE CONTRACTOR THAT THE EXISTING/PROPOSED UTILITIES WILL NOT BE AFFECTED. IF IT IS DETERMINED THAT THE UTILITIES WILL BE UNAFFECTED, VIBRATORY ROLLERS MAY BE USED ON THIS PROJECT. THIS DOES NOT RELIEVE THE CONTRACTOR OF DENSITY REQUIREMENTS FOR THE BITUMINOUS PAVEMENTS.
- 10. THE CONTRACTOR SHALL BE AWARE THAT THERE ARE MANHOLES & VALVES LOCATED WITHIN THE RESURFACING LIMITS. CARE SHALL BE TAKEN IN THESE LOCATIONS DURING MILLING OPERATIONS.
- 11. AGGREGATE FOR MAINTAINING ACCESS TO PRIVATE PROPERTY AND SIDE ROADS IS INCLUDED IN THE PRICE OF TEMP ACCESS. THIS AGGREGATE CAN SUBSEQUENTLY BE USED AND PAID FOR AS AGGREGATE BASE COURSE TYPE B FOR WIDENING WHEN APPROVED BY THE ENGINEER.

THE MANUFACTURER SHALL SPECIFICALLY RECOMMEND ALL EROSION CONTROL PRODUCTS FURNISHED FOR THE USE SPECIFIED IN THE EROSION CONTROL PLAN, PRIOR TO THE APPROVAL AND USE OF THE PRODUCT, THE CONTRACTOR SHALL SUBMIT TO THE ENGINEER A NOTARIZED CERTIFICATE BY THE PRODUCT AND THAT THE PHYSICAL PROPERTIES REQUIRED FOR THIS APPLICATION ARE MET OR EXCEEDED.
