## **TRAFFIC BARRIER TERMINAL, TYPE 6A (SPECIAL)**

Description This work shall consist of the furnishing and erecting of a Traffic Barrier Terminal, Type 6A (Special), including the field adjustments of guardrail lengths, drilling of mounting holes, re-galvanizing of all exposed metal surfaces and any other items needed to complete the work. This work shall conform to the application portion of Section 631 of the Standard Specifications.

Traffic Barrier Terminal Type 6A (Special) shall be as shown on Standard 631032-09 and the detail seen in the plans, except the rail on the south-east quadrant of S.N. 023-2010 shall be bent between posts 1 to 11 with a radius of 16 FT. The Contractor shall verify all dimensions and modifications in the field prior to ordering materials.

The terminal shall be installed according to the manufacturer's specifications and shall include all necessary transitions between the terminal and the items to which it is attached.

Method of Measurement The method of measurement shall be in accordance with Article 631.12 of the Standard Specifications.

Basis of Payment The basis of payment shall be the contract unit price each for TRAFFIC BARRIER TERMINAL TYPE 6A (SPECIAL). All bolts, nuts, block-outs, galvanizing, or any other items needed to complete this work shall be included, and no other compensation will be allowed.
