


## PAVEMENT MARKING LEGEND

- 7 6" (150) SKIP-DASH (WHITE)
- 8 4" (100) SOLID (WHITE)

- 11 24" (600) STOP BAR (WHITE)

1. RAISED AND CORRUGATED MEDIANS SHALL BE OUTLINED WITH 2 IF PRESENT.


