## SPECIAL PROVISIONS

The following Special Provision supplement the "Standard Specifications for Road and Bridge Construction," adopted January 1, 2007, the latest edition of the "Illinois Manual on Uniform Traffic Control Devices for Streets and Highways", and the "Manual of Test Procedures for Materials" in effect on the date of invitation for bids and the Supplemental Specifications and Recurring Special Provisions indicated on the Check Sheet included herein which apply to and govern the construction of Section 08-00170-00-RS in Franklin County, and in case of conflict with any part, or parts of said Specifications, the said Special Provisions shall take precedence and shall govern.

## **DESCRIPTION OF WORK**

The proposed improvement consists of the construction of the removal of the existing Hot-mix asphalt patches, the placement of the placement of Hot-mix asphale Surface Course, Mix C, N70, 1-1/2" and Hot-mix asphalt Binder Course, Mix B, N50, 2 1/4", the placement of crushed stone shoulders, and miscellaneous items needed to complete the improvement.

## TRAFFIC CONTROL

The Contractor will be required to maintain one way traffic at all times.

Traffic Control shall be in accordance with the applicable sections of the "Standard Specifications", the applicable guidelines contained in the Illinois Manual on Uniform Traffic Control Devices for Streets and Highways, these special provisions, and any special details and highway standards contained herein and in the plans.

The Contractor shall furnish the name of the individual in his direct employ who is to be responsible for the installation and maintenance of the traffic control for this project. If the actual installation and maintenance are to be accomplished by a Sub-Contractor, consent shall be requested of the Engineer at the time of the Preconstruction meeting in accordance with Article 108.01 of the "Standard Specifications". This shall not relieve the Contractor of the foregoing requirement for a responsible individual in his direct employ. The Department will provide the Contractor the name of its representative who will be responsible for the administration of the traffic control plan.

Special attention is called to Article 107.09 and 107.14 of the "Standard Specifications" and the following Highway Standards: 701301, 701306, 701311, and 701901.

The cost for the materials, labor and equipment necessary for Traffic Control in accordance with the standards mentioned above will be included in the total price of the contract, and no additional compensation will be allowed.
