INTERIM COMPLETION DATE

The pavement removal and replacement work shall be completed and IL 34 reopened to two way traffic by September 1, 2012. Should the Contractor fail to meet the interim stage deadline then liquidated damages, according to Article 108.09 will apply for each additional calendar day.

The interim completion date is based on accelerated award and execution of the contract. If, due to no fault of the contractor, the contract has not been awarded and executed by July 30, 2012 the interim completion date will be adjusted so that the contractor will have a minimum of 33 consecutive calendar days to complete the work necessary to reopen IL 34 to two way traffic. Liquidated damages will apply to the adjusted Interim Completion Date.
