## **CONCRETE CURB, TYPE B (SPECIAL)**


<u>Description:</u> This work shall consist of constructing a 6" wide concrete curb in accordance with the applicable portions of Sections 606 to serve as a buffer for paving purposes adjacent to proposed retaining walls and/or as directed by the Engineer.

<u>Materials and Equipment:</u> Materials and equipment utilized shall be in accordance with Articles 606.02 and 606.03 respectively of the Standard Specifications.

<u>Construction Requirements</u>: Construction shall conform to the details shown in the Plans and must meet all applicable portions of section 606 of the Standard Specifications. The depth of concrete curb shall extend to match the depth of the adjacent Hot Mix Asphalt Shoulder

<u>Method of Measurement</u>: This work will be measured for payment, complete in place and accepted, in units of feet along the face of the proposed retaining wall.

<u>Basis of Payment:</u> This work will be paid for at the contract unit price per foot, for CONCRETE CURB, TYPE B (SPECIAL).
