REASON FOR ADDENDUM:

The pay item Refurbish Taxi Guidance Sign (AR125984) originally called for refurbishing signs that were to be installed on Project MLI-3854 (Taxiway P, Phase II-Middle Paving), from incandescent signs to LED signs meeting the current FAA standards for constant illumination. Since the time that project MLI-3854 was bid it has been determined that the incandescent signs will be changed to LED signs thus eliminating the need to refurbish them. It has been further determined by FAA that this pay item can be used to change five (5) signs on this project. The special provision describing the work item has been modified to clarify the fact that the refurbished sign will actually be a new LED sign to be installed on an existing sign base.

1. <u>SECTION III SPECIAL PROVISIONS FOR TAXIWAY P, PHASE IV-EAST PAVING, PAGE 84,</u> <u>SECTION 125-3.14 AR125984 REFURBISH TAXI GUIDANCE SIGN:</u> ADD: This item shall include all work items that are necessary to remove the existing signs and supply and install new signs with LED lighting systems (including LED lamps and isolation transformers as required by the manufacturer). New signs shall meet the requirements of sections 125-2.16 and 125-3.70. Existing concrete sign bases (extend bases as required for new sign) and splice cans may be reused.
