


- 1. LOCATION OF UTILITIES AND PROPERTY LINES ARE FROM THE BEST INFORMATION AVAILABLE. EXACT LOCATION AND COMPLETENESS ARE NOT
- 2. THE CONTRACTOR SHALL VERIFY THE LOCATION OF UNDERGROUND UTILITIES WITH THE UTILITY OWNERS PRIOR TO DOING ANY WORK IN THE VICINITY. THE CONTRACTOR SHALL COMPLY WITH REQUIREMENTS OF UTILITY OWNERS REGARDING NOTICE OF WORK AND PROTECTION OF UTILITIES. THE CONTRACTOR SHALL COMPLY WITH THE CITY OF CHICAGO, DEPARTMENT OF TRANSPORTATION DAMAGE PREVENTION PROTOCOL CITY INFRASTRUCTURE DEPARTMENTS, ALL UTILITIES SHALL BE NOTIFIED AT LEAST 48 HOURS BEFORE CONSTRUCTION. (CALL DIGGER 312-744-7000)
- 3. IF ANY PUBLIC OR PRIVATE UTILITIES CROSS THE WATER MAIN TRENCH AND SHALL REMAIN IN PLACE, THE CONTRACTOR SHALL PROTECT SAID UTILITY IN CONFORMANCE WITH THE SPECIAL PROVISIONS OR AS DIRECTED BY THE
- 4. TEST PITS SHALL BE EXCAVATED IN ADVANCE OF PIPELINE CONSTRUCTION IN ORDER TO CONFIRM DEPTH AND LOCATION OF EXISTING UTILITIES AND WHEN DIRECTED BY THE ENGINEER, NO ADDITIONAL PAYMENT WILL BE MADE FOR
- 5. WORK INDICATED ON THE PLANS AND NOT REFERENCED TO A BID ITEM SHALL BE CONSIDERED INCLUDED WITHIN THE BID ITEM TO THE WORK TO WHICH IT APPLIES AND NO ADDITIONAL COMPENSATION WILL BE ALLOWED.
- 6. WATER MAIN AND FITTINGS LOCATIONS SHOWN ON THE DRAWINGS FOR THE NEW WATER MAINS AND APPURTENANCES MAY BE CHANGED BY THE ENGINEER DUE TO FIELD CONDITIONS. NO ADDITIONAL COMPENSATION WILL BE ALLOWED FOR SUCH CHANGES, UNLESS PREVIOUSLY APPROVED BY THE ENGINEER.
- 7. THE OPERATION OF ALL VALVES REQUIRED FOR SHUTDOWN SHALL BE PERFORMED BY CHICAGO DEPARTMENT OF WATER MANAGEMENT (CDWM) FORCES PURSUANT TO A 72 HOUR ADVANCE NOTIFICATION TO THE DEPARTMENT. ANY VALVE FOUND NOT OPERABLE WILL BE REPAIRED OR REPLACED BY CDWM.
- 8. REMOVE AND PROPERLY DISPOSE OF ALL WATER ENTERING ANY EXCAVATION INCLUDING LEAKAGE FROM EXISTING WATER MAINS. ALL EXCAVATIONS ASSOCIATED WITH THE WATER MAIN WORK SHALL BE KEPT DRY.
- 9. ALL OPENINGS IN EXISTING WATER MAINS SHALL BE PLUGGED OR CAPPED WITH DUCTILE IRON FITTINGS UNTIL THE MAIN IS ABANDONED.
- 10. ALL VALVE BASINS SHALL BE CONSTRUCTED OF PRE-CAST REINFORCED CONCRETE UNLESS DIRECTED OTHERWISE BY THE ENGINEER.
- 11. NOTES INDICATING S.N.L., E.W.L., ETC. MEAN SOUTH OF THE NORTH PROPERTY LINE, EAST OF THE WEST PROPERTY LINE, ETC. AND ARE MEASURED FROM THE NEAREST STREET.
- 12. IF A STANDARD MECHANICAL JOINT SLEEVE DOES NOT FIT TO MAKE CONNECTION OF THE NEW PIPE TO THE EXISTING PIPE, A TRANSITION SLEEVE MUST BE USED. NO GRINDING OF THE EXISTING PIPE IS PERMITTED.



- 20. CONTRACTOR SHALL CONSTRUCT THE IMPROVEMENTS ONLY WITHIN THE RIGHT-OF-WAY. THE CONTRACTOR SHALL BE RESPONSIBLE FOR ANY AND ALL DAMAGE TO PRIVATE PROPERTY AND SHALL REPAIR SAID DAMAGE AT OWN EXPENSE TO THE SATISFACTION OF THE ENGINEER.

CONSTRUCTION/SEQUENCING NOTES:

- 1. CONTACT CHICAGO DEPARTMENT OF WATER MANAGEMENT (CDWM) TO ARRANGE FOR THE SHUTDOWN OF THE EXISTING 24" WATER MAIN (312-744-5070). COORDINATE THE SHUTDOWN PERIOD WITH McCORMICK PLACE AND THEIR EVENT SCHEDULE.
- 2. CUT OUT AND REMOVE SECTION OF EXISTING 24" WATER MAIN. INSTALL 1-24" BUTTERFLY VALVE AND 2-2" TEST TAPS AT STA 53+18. INSTALL 24" PIPE TO THE SOUTH. TEMPORARILY PLUG AND BRACE WITH 1-24" MJ PLUG. BUILD BASINS TO CONTAIN BUTTERFLY VALVE AND TEST
- 3. CONTACT CDWM TO FILL, FLUSH AND RETURN EXISTING 24" WATER MAIN TO THE NORTH OF THE NEW VALVE BACK TO SERVICE NO LATER THAN THE DATE AGREED UPON WITH CDWM AS PART OF THE SHUTDOWN.
- 4. INSTALL 72'- 42" STEEL CASING PIPE BETWEEN STATIONS 52+30 AND 53+01.
- 5. INSTALL 136'- 42" STEEL CASING PIPE BETWEEN STATIONS 80+36 AND 81+72.
- 6. INSTALL 24" WATER MAIN IN CASING PIPES USING CASING SPACERS.
- 7. REMOVE TEMPORARY PLUG AND CONNECT TO 24" PIPE TO NORTH. INSTALL 1-24" X 4" TEE WITH OUTLET ROTATED UP AT APPROXIMATELY STATION 53+07. INSTALL 1-4" MJ PLUG IN OUTLET. INSTALL 1-24" X 1/4 BEND AT APPROXIMATELY STATION 53+03. CONNECT TO 24" PIPE IN CASING WITH 1-24" MJ SLEEVE. BUILD THRUST RESTRAINT.
- 8. INSTALL 1-24" X 1/4 BEND AT APPROXIMATELY STATION 52+26. INSTALL 24" WATER MAIN TO SOUTH. BUILD THRUST RESTRAINT.
- 9. INSTALL 24" X 1/16 BEND AT APPROXIMATELY STATION 50+48.
- 10. INSTALL 1-24" BUTTERFLY VALVE AND 2-2" TEST TAPS AT STA 50+38. BUILD BASINS TO CONTAIN BUTTERFLY VALVE AND TEST TAPS (SEE DETAILS).
- 11. INSTALL 24" X 1/8 BEND AT APPROXIMATELY STATION 50+28. BUILD THRUST RESTRAINT.

- 12. INSTALL 1-24" X 24" TEE WITH 1-24" MJ PLUG FOR INSPECTION MANHOLE AT STATION 50+24. BUILD BASIN TO CONTAIN INSPECTION TEE (SEE DETAILS).
- 13. INSTALL 1-24" X 24" TEE AT STA 50+19 (STA 80+00 \$ WM_RAMPEN_S). INSTALL 24" PIPE TO WEST AND TEMPORARILY PLUG AND BRACE. BUILD THRUST RESTRAINT.
- 14. INSTALL 1-24" BUTTERFLY VALVE AND 2-2" TEST TAPS AT STA 80+19. BUILD BASINS TO CONTAIN BUTTERFLY VALVE AND TEST TAPS (SEE DETAILS).

<u>PLAN DETAIL</u> THRUST RESTRAINT - TYPE 1 (1 THUS)





<u>PLAN DETAIL</u> THRUST RESTRAINT - TYPE 2 (2 THUS)





TH #1 - Unable to visually verify the utility due to gravel/fill caving in the test hole. Tapped what we believe to be the utility with the airlance to verify size, shape and depth.

TH #2 - Found 8" Steel main wrapped in yellow FBE.

TH #3 - Unable to visually verify the utility due to sand and huge rocks caving in the test hole. Had to stop digging for safety reasons. Tapped what we believe to be the utility with the airlance to get manual depth.

But unable to determine the size.

TH#8 - Found 8" Steel main wrapped in yellow FBE.

TH#9 - Excavated to a depth of 5' and did not find evidence of a water main thrust block. Did encounter a lot of large debris i.e. rocks, concrete, wood.

TH#10 - No evidence of bend or thrust block found. 36" water main was wrapped in black p.e. liner. Reference point was placed in line with top of pipe.

TH#10A - Reference point was placed in line with north edge of pipe.

TH#10B - Reference point was placed in line with South edge of pipe.

TH#11 - Found concrete thrust block almost covering what appeared to be the top crown of pipe. Water main was wrapped in black p.e. liner.

TH#11A - Top of concrete thrust block. Same reference point was used for 11B.

TH#11B - Found a 4"x36" concrete duct/ cap{ Could visually see 2 conduits directly underneath this duct/cap which is believed to be the fiber optic. Reference point was placed in line with the western edge of duct/cap. Reference point same as 11A.

TH#12 - Excavated to a depth of 5' and did find thrust block to be in conflict. Edge of thrust was found to be 2' west of this location.

TH#13 - Reference point placed in line with top of pipe.

TH#13A - Reference point was placed in line with North edge of pipe.

TH#13B - Reference point was placed in line with South edge of pipe.

TH#14A - Reference point was placed in line with North edge of pipe. TH#14B - Reference point was placed in line with South edge of pipe.

TH#15 - Found large wooden rail road ties, unsure if protection for water main. We were able to probe between 2 of the ties and tapped what is believed to be the water main. Size of pipe could not be determined.

TH#16 - Unable to visually see the utility due to large rocks within the excavated hole. However, by utilizing the air lance we were able to tap and feel what is believed to be the top of pipe.

TH#17 -Unable to visually see the utility due to loose pea gravel continually collapsing within the excavated hole. However, by utilizing the air lance we were able to tap and feel what is believed to be the top of pipe.

TH#20 - Found the edge of the retaining wall footing to the parking garage wall. Reference point was placed directly in line with the edge of footing.

TEMPORARY IDOT LIGHTING PLANS


