REMOVAL AND DISPOSAL OF REGULATED SUBSTANCES (PROJECT SPECIFIC)

Description. This work shall consist of the removal and disposal of regulated substances according to Section 669 of the Standard Specifications as revised below.

Contract Specific Sites. The excavated soil and groundwater within the areas listed below shall be managed as either "uncontaminated soil", hazardous waste, special waste or non-special waste. For stationing, the lateral distance is measured from centerline and the farthest distance is the offset distance or construction limit, whichever is less.

Intersection of 47th Street and Veeck Park Entrance, Hinsdale, Cook County

• All excavation planned at the northwest quadrant, and northeast quadrant at the intersection of 47th Street and Veeck Park Entrance. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Shoulder Construction Excavation, 47th Street, Hinsdale, Cook County

 Station 28+25 to Station 35+00 (CL 47th Street), 0 to 35 feet LT. All excavation planned for shoulder construction excavation. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of 47th Street and Commonwealth Avenue, Western Springs, Cook County

• All excavation planned at the southwest quadrant, and southeast quadrant at the intersection of 47th Street and Commonwealth Avenue. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Shoulder Construction Excavation, 47th Street, Western Springs, Cook County

 Station 45+75 to Station 49+60 (CL 47th Street), 0 to 35 feet LT. All excavation planned for shoulder construction excavation. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of 47th Street and Fair Elms Avenue, Western Springs, Cook County

 All excavation planned at the southwest quadrant, and southeast quadrant at the intersection of 47th Street and Fair Elms Avenue. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of 47th Street and Central Avenue (west intersection), Western Springs, Cook County

• All excavation planned at the southwest quadrant, and southeast quadrant at the intersection of 47th Street and Central Avenue (west intersection). The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of 47th Street and Central Avenue (east intersection), Western Springs, Cook County

• All excavation planned at the northwest quadrant, northeast quadrant, and southwest quadrant at the intersection of 47th Street and Central Avenue (east intersection). The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of 47th Street and Woodland Avenue (west intersection), Western Springs, Cook County

• All excavation planned at the southwest quadrant, and southeast quadrant at the intersection of 47th Street and Woodland Avenue (west intersection). The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of 47th Street and Woodland Avenue (east intersection), Western Springs, Cook County

• All excavation planned at the northwest quadrant, and northeast quadrant at the intersection of 47th Street and Woodland Avenue (east intersection). The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of 47th Street and Grand Avenue, Western Springs, Cook County

• All excavation planned at the northwest quadrant, northeast quadrant, southwest quadrant, and southeast quadrant at the intersection of 47th Street and Grand Avenue. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of 47th Street and Lawn Avenue (west intersection), Western Springs, Cook County

• All excavation planned at the northwest quadrant, and northeast quadrant at the intersection of 47th Street and Lawn Avenue (west intersection). The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of 47th Street and Lawn Avenue (east intersection), Western Springs, Cook County

• All excavation planned at the southwest quadrant, and southeast quadrant at the intersection of 47th Street and Lawn Avenue (east intersection). The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Intersection of 47th Street and Wolf Road, Western Springs, Cook County

• All excavation planned at the northwest quadrant, northeast quadrant, southwest quadrant, and southeast quadrant at the intersection of 47th Street and Wolf Road. The Engineer has determined this material meets the criteria of and shall be managed in accordance with Article 669.05(a)(1). Potential contaminants of concern sampling parameters: VOCs, SVOCs and Metals.

Work Zones

Three distinct OSHA HAZWOPER work zones (exclusion, decontamination, and support) shall apply to projects adjacent to or within sites with documented leaking underground storage tank (LUST) incidents, or sites under management in accordance with the requirements of the Site Remediation Program (SRP), Resource Conservation and Recovery Act (RCRA), or Comprehensive Environmental Response, Compensation and Liability Act (CERCLA), or as deemed necessary. For this project, the work zones apply for the following ISGS PESA Sites: **None**
