THE CONTRACTOR SHALL COORDINATE CONSTRUCTION
ACTIVITIES WITH UTILITY COMPANIES AND THE CITIES
OF COUNTRY CLUB HILLS, HAZEL CREST, NEW LENOX, ORLAND PARK,
AND THE VILLAGES OF MOKENA AND TINLEY PARK

THE CONTRACTOR WILL NOT BE ALLOWED TO SET UP A YARD OR FIELD OFFICE ON STATE PROPERTY WITHOUT WRITTEN PERMISSION FROM THE DEPARTMENT.

THE REMOVAL OF GUARDRAIL TERMINAL SECTIONS SHALL BE INCLUDED IN THE UNIT PRICE PER FOOT FOR "GUARDRAIL REMOVAL."

ALL PERIMETER EROSION BARRIER, EROSION CONTROL BLANKET, AND SEEDING LOCATIONS WILL BE DETERMINED IN THE FIELD BY THE ENGINEER.

IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO VERIFY ALL DIMENSIONS AND CONDITIONS EXISTING IN THE FIELD PRIOR TO CONSTRUCTION AND ORDERING OF MATERIALS.
