TRAFFIC CONTROL ITEMS

The traffic control shall be in accordance with the applicable sections of the Standard Specifications for Road and Bridge Construction, the guidelines contained in the Illinois Manual on Uniform Traffic Control Devices for Streets and Highways, the Supplemental Specifications, these special provisions and any special details and highway standards contained herein and in the plans. Special attention is called to Art. 107.09 and 107.14 of the Standard Specifications.

The applicable Traffic Control Standards for this project are:

701101-05	Off-Road Operations, Multilane, 15' to 24" from Pavement Edge
701301-04	Lane Closure, 2L 2W, Short Time Operations
701501-06	Urban Lane Closure, 2L, 2W, Undivided
701601-09	Urban Lane Closure, Multilane, 1W or 2W with non-traversable median
	Sidewalk, Corner or Crosswalk Closure

The Contractor shall insure that all businesses and residences always have access to their properties during construction. Modifications to the Traffic Control Standards to fit field conditions shall be incidental to the pay items included below.

Any side road flaggers required at the request of the Engineer during while Standard 701501 is being utilized shall be included in the lump-sum cost for TRAFFIC CONTROL AND PROTECTION STANDARD 701501.

Payment for this work shall be at the contract lump sum price for TRAFFIC CONTROL AND PROTECTION STANDARD 701501, TRAFFIC CONTROL AND PROTECTION STANDARD 701601 and TRAFFIC CONTROL AND PROTECTION STANDARD 701801.

MAINTAINING TRAFFIC SIGNS
