SUB-BASE GRANULAR MATERIAL, TYPE A 6"

In addition to the requirements of Section 311 of the Standard Specifications, this work should include earth excavation. Earth excavation may be required in addition to the pavement removal to obtain the depth needed for the sub-base, HMA binder, and HMA surface as shown on the typical sections for locations 3, 4, and 5.

This work will not be paid for separately but included in the contract unit price per square yard for SUB-BASE GRANULAR MATERIAL, TYPE A 6".

LANE RENTAL

<u>Description</u>. The Contractor will be charged a monetary assessment for each day or part of a day that each lane of I-57 in Franklin County is closed to traffic in excess of an accumulated total allowed of $\underline{7}$ days to perform all pavement patching. Lane Rental will be assessed a minimum of one day for the time the Contractor occupies or obstructs part of the roadway. Lane Rental in excess of allotted number of days will be deducted from the monthly progress payments.

<u>Lane Rental</u>. The Contractor will be assessed a minimum of a one day Lane Rental charge for each lane closure or obstruction during the calendar day or partial calendar day. The length of the Lane Rental shall not exceed the 5 mile policy limit for lane closure in a single stretch.

A Lane Rental closure will be measured as a 3.6 m (12 foot) wide traffic lane, or any part thereof per direction of travel that is closed to traffic. If a northbound lane and a southbound lane are both closed, then two closures will be assessed.

<u>Disincentive Plan (Lane Rental Days Exceeding Allotted Days)</u>. The Contractor shall be liable to the Department in the amount of \$14,000 for each Lane Rental day beyond the number of Lane Rental days allowed in the Contract. There is no limit to the number of Lane Rental days assessed that exceed the allotted days.

(a) Portland Cement. Acceptance of portland cement shall be according to the current Bureau of Materials and Physical Research's Policy Memorandum, "Portland or Blended Cement Acceptance Procedure for Qualified and Non-Qualified Plants".
