



THE CONTRACTOR SHALL COORDINATE CONSTRUCTION ACTIVITIES WITH UTILITY COMPANIES AND THE VILLAGE OF VILLA PARK. BEFORE STARTING ANY EXCAVATING THE CONTRACTOR SHALL CONTACT "JULIE" AT (800) 892-0123 FOR FIELD LOCATIONS OF BURIED ELECTRIC, TELEPHONE GAS, OR OTHER FACILITIES. (48 HOUR NOTIFICATION IS REQUIRED)

TEN FOOT (10') TRANSITIONS SHALL BE USED TO MATCH PROPOSED CURB AND GUTTER AND MEDIAN ITEMS OF WORK TO EXISTING CURBS AND GUTTERS AND MEDIANS IN THE FIELD, UNLESS OTHERWISE SHOWN, THE TRANSITIONS SHALL BE PAID FOR AT THE CONTRACT UNIT PRICE FOR THE PROPOSED ITEMS OF WORK SPECIFIED.

FULL DEPTH SAW CUT SHALL BE PERFORMED PRIOR TO REMOVAL OF COMBINATION CONCRETE CURB & GUTTER. FULL DEPTH SAW CUT WILL BE INCIDENTAL TO COMBINATION CONCRETE CURB AND GUTTER REMOVAL AND REPLACEMENT ITEM.

RESTORATION BEHIND INSTALLED CURB & GUTTER SHALL BE CONSIDERED INCIDENTAL TO COMBINATION CONCRETE CURB AND GUTTER

BARRICADES: THE CONTRACTOR SHALL PROVIDE AND INSTALL TWO (2) WEIGHTED SANDBAGS ON EACH TYPE I OR TYPE II BARRICADE USED. ONE (1) WEIGHTED SAND BAG SHALL BE USED ACROSS EACH BOTTOM RAIL.

WHEN MILLED PAVEMENT IS OPEN TO TRAFFIC THE MAXIMUM GRADE DIFFERENTIAL BETWEEN PASSES OF THE MILLING MACHINE SHALL NOT EXCEED ONE AND ONE-HALF INCHES (1 1/2") WHERE THE SPEED LIMIT IS FORTY-FIVE MILES PER HOUR (45 MPH) OR LESS AND ONE INCH (1") WHERE THE SPEED LIMIT IS GREATER THAN FORTY-FIVE MILES PER HOUR (45 MPH).
