THIS PROJECT CONSISTS OF CONSTRUCTING A CLASS E FENCE (6') ALONG THE NORTH AIRPORT PROPERTY LINE.

AIRPORT SECURITY NOTE

AIRPORT SECURITY WILL BE MAINTAINED AT ALL TIMES. THE CONTRACTOR WILL CLOSE AND LOCK THE EXISTING GATE IN THE HAUL ROUTE AT THE END OF EACH WORKING DAY.

UTILITY NOTE

THE CONTRACTOR SHALL CONTACT ALL UTILITY COMPANIES AND AGENCIES WHICH HAVE LINES OR CONDUITS IN THE PROPOSED WORK AREA. ALL LINES AND CONDUITS SHALL BE LOCATED AND IDENTIFIED FOR DEPTH BEFORE ANY EXCAVATION BEGINS. THE CONTRACTOR WILL CALL J.U.L.I.E. (1-800-892-0123) TO ACCOMPLISH THE ABOVE. IT IS THE CONTRACTOR'S RESPONSIBILITY TO IDENTIFY ALL UNDERGROUND NON-JULIE UTILITIES LOCATED WITHIN THE PROPOSED CONSTRUCTION LIMITS. THESE UNDERGROUND IMPROVEMENTS WILL BE LOCATED AT THE CONTRACTOR'S OWN EXPENSE PRIOR TO THE START OF CONSTRUCTION ACTIVITIES.

HEIGHT OF CONSTRUCTION EQUIPMENT

THE MAXIMUM ANTICIPATED HEIGHT OF THE CONSTRUCTION EQUIPMENT WILL BE 15 FEET. THE TALLEST EQUIPMENT IS EXPECTED TO BE A CONCRETE TRUCK.

EQUIPMENT PARKING AND STORAGE AREA

THE LOCATION OF THE EQUIPMENT PARKING AND STORAGE AREA IS AS SHOWN ON THIS SHEET. THE CONTRACTOR WILL BE REQUIRED TO MAINTAIN THE PROPOSED EQUIPMENT PARKING AND STORAGE AREA THROUGHOUT THE COURSE OF THE PROJECT. ANY PROPERTY DAMAGE OUTSIDE OF THESE DESIGNATED AREAS WILL BE REPAIRED BY THE CONTRACTOR AND AT THE CONTRACTOR SOWN EXPENSE. AT THE CONCLUSION OF THE PROJECT THE CONTRACTOR WILL RESTORE THE EQUIPMENT PARKING AND STORAGE AREA TO THEIR ORIGINAL STATE. RESTORATION OF THE EQUIPMENT PARKING AND STORAGE AREAS WILL BE CONSIDERED INCIDENTAL TO THE PROJECT AND NO ADDITIONAL COMPENSATION WILL BE ALLOWED.

CONTRACTOR RESPONSIBILITIES

THE CONTRACTOR'S EMPLOYEES WILL PARK THEIR VEHICLES IN THE EXISTING AUTO PARKING LOT. ONLY CONTRACTOR VEHICLES WILL BE ALLOWED OUTSIDE THIS AREA.

THE CONTRACTOR AND HIS EMPLOYEES WILL BE RESTRICTED TO THE WORK AREA AND ALL OTHER AREAS OF THE AIRPORT ARE "OFF LIMITS" TO THEM.

THE WORK AREA WILL BE DEFINED AS FOLLOWS: THE DEFINED WORK AREA WILL BE 10' ON THE AIRPORT SIDE OF THE PROPOSED FENCE ALICNMENT OR EXISTING FENCE REMOVAL. THE CONTRACTOR MUST KEEP HIS EQUIPMENT WITHIN THESE WORK AREA LIMITS.

SEEDING NOTE

ALL AREAS DISTURBED DURING CONSTRUCTION SHALL BE LIMED, SEEDED, AND MULCHED IN ACCORDANCE TO THE SPECIFICATIONS AND SPECIAL PROVISIONS.


