- IN AREAS WHERE PATCHING OPERATIONS OCCUR WITHIN THE LIMITS OF THE REDUCED RESURFACING THICKNESS NEAR OVERHEAD STRUCTURES, THE DEPTH OF THE PATCHING SHALL BE REDUCED TO MEET THE EXISTING PAVEMENT THICKNESS
