A. GENERAL

ALL CONSTRUCTION SHALL BE DONE IN ACCORDANCE WITH THE "STANDARD SPECIFICATIONS FOR ROAD AND BRIDGE CONSTRUCTION", ADDPTED JANUARY 1, 2002 ("STANDARD SPECIFICATIONS"): THE "SUPPLEMENTAL SPECIFICATIONS AND RECURRING SPECIAL PROVISIONS", ADDPTED JANUARY 1, 2005; THE LATEST FOR STREETS AND HIGHWAYS" (MUTCH); THE DETAILS INCLUDED IN THE PLANS; AND THE SPECIAL PROVISIONS INCLUDED IN THE PLANS; AND THE SPECIAL PROVISIONS INCLUDED IN THE CONTRACT DOCUMENTS.

NO WORK SHALL COMMENCE UNTIL TRAFFIC CONTROL REQUIREMENTS ARE MET AND APPROPRIATE PERMITS HAVE BEEN OBTAINED FROM THE VILLAGE OF ELK GROVE VILLAGE, THE COOK COUNTY HICHMAY DEPARTMENT, THE DU PAGE COUNTY DIVISION OF TRANSPORTATION AND THE ILLINOIS DEPARTMENT OF TRANSPORTATION.

ALL UTILITY COMPANIES, SCHOOL DISTRICTS AND LOCAL POLICE AND FIRE DE-PARTMENTS SHALL BE NOTIFIED BY THE CONTRACTOR AT LEAST 72 HOURS PRIOR TO THE STRAT OF CONSTRUCTION.

UNLESS OTHERWISE AUTHORIZED BY THE ENGINEER, ALL EXISTING ACCESS POINTS SHALL BE MAINTAINED AT ALL TIMES BY THE CONTRACTOR.

RADII FOR ROADWAY PAVEMENTS ARE MEASURED TO THE EDGE OF PAVEMENT. ALL OTHER RADII ARE MEASURED TO THE FACE OF CURB.

6. WHERE SECTION OR SUBSECTION MONUMENTS ARE ENCOUNTERED, THE ENGINEER SHALL BE NOTIFIED BEFORE SUCH MONUMENTS ARE REMOVED. THE CONTRACTO SHALL CAREFULLY PRESERVE ALL PROPERTY MARKERS AND MONUMENTS UNTIL TOWNER, AN AUTHORIZED SURVEYOR OR AGENT HAS WITNESSED OR OTHERWISE REFERENCED EACH LOCATION.

7. ALL ELEVATIONS SHOWN ON THESE PLANS ARE ON U.S.G.S. DATUM

ALL PAVEMENT ELEVATIONS SHOWN ON THE PLANS ARE FINISHED GRADES OF PROPOSED SURFACE COURSE.

THE THICKNESSES OF BITUMINOUS MIXTURES SHOWN ON THE PLANS ARE NOMINAL DEVIATIONS MAY OCCUR DUE TO IRREGULARITIES IN THE SURFACE OR BASE UPON WHICH THE BITUMINOUS MATERIALS ARE PLACED.

ANY REFERENCE TO "STANDARDS" IN THE PLANS OR SPECIAL PROVISIONS SHALL BE INTERPRETED TO MEAN THE DEPARTMENT'S LATEST REVISION OF THAT STANDARD.

11. THE MAXIMUM ALLOWABLE DIFFERENTIAL IN ELEVATION BETWEEN ADJACENT OPEN TRAFFIC LANES SHALL BE 2-1/4 INCHES.

12. ALL UNBALLASTED TYPE I AND II BARRICADES SHALL HAVE TWO SANDBAGS ON THE BOTTOM RAILS.

13. ALL REFERENCES TO "ENGINEER" IN THE PLANS AND CONTRACT DOCUMENTS SHALL BE INTERPRETED TO MEAN THE RESIDENT ENGINEER. 14. IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO VERIFY ALL DIMENSIONS AND CONDITIONS EXISTING IN THE FIELD PRIOR TO ORDERING MATERIALS AND BEGINNING CONSTRUCTION.

15. THE CONTRACTOR WILL NOT BE ALLOWED TO USE EXISTING FIRE HYDRANTS TO OBTAIN WATER FOR CONSTRUCTION PURPOSES. THE CONTRACTOR MAY OBTAIN WATER FROM THE VILLAGE OF ELK GROVE VILLAGE AT THE VILLAGE'S PUBLIC WORKS FACILITY ON LANDMETER ROAD.

C. MAILBOXES

1. THE CONTRACTOR WILL BE REQUIRED TO TEMPORARILY RE—SET ALL EXISTING MAIL—BOXES WHICH INTERFERE WITH HIS CONSTRUCTION OF DEPATIONS AND, AFTER COMPLETION OF ROADWAY CONSTRUCTION, TO SET THEM IN THEIR PERMANENT LOCA—TIONS AS SHOWN ON THE PLANS AND/OR DIRECTED BY THE ENGINEER. (THE CONTRACTOR WILL ALSO BE RESPONSIBLE FOR COORDINATING THIS WORK WITH THE POST OFFICE.) THIS WORK SHALL BE IN CONFORMANCE WITH ARTICLE 107.20 OF THE "STANDARD SPECIFICATIONS".

2. DAMAGE TO ANY MAILBOX OR POST CAUSED BY THE CONTRACTOR'S OPERATIONS SHALL BE REPAIRED OR REPLACED AT THE CONTRACT'S EXPENSE. IF THE ENGINEER DIRECTS THE CONTRACTOR TO REPLACE ANY UNDAMAGED POST, THE FURNISHING AND PLACING OF SAME WILL BE PAID FOR IN ACCORDANCE WITH ARTICLE 109.04.

D. UTILITIES

1. THE CONTRACTOR SHALL COORDINATE CONSTRUCTION ACTIVITIES WITH UTILITY COMPANIES. THE LOCATIONS OF PUBLIC OR PRIVATE UTILITIES SHOWN ON THE PLANS ARE APPROXIMATE, AND THE ENDINER DOES NOT GUIRANTEE THEIR ACCURACY. THE CONTRACTOR WILL BE REQUIRED TO ASCERTAIN THE EXACT LOCATIONS OF SUCH UTILITIES, AND EXCERCISE CARE DURING HIS CONSTRUCTION OPERATIONS SO AS NOT TO DAMAGE THEM, IN ACCORDANCE WITH THE SPECIAL PROVISIONS AND ARTICLE 107.31 OF THE "STANDARD SPECIFICATIONS," ILL CONTRACTOR WILL BE RESPONSIBLE FOR CONTRACTING THE OWNERS OF ALL EXISTING UTILITIES SO THAT THEIR FACILITIES MAY BE LOCATED AND ADJUSTED OR MOVED, IF NECESSARY, PRIOR TO THE START OF CONSTRUCTION OPERATIONS.

3. THE CONTRACTOR SHALL RECEIVE NO ADDITIONAL COMPENSATION FOR CONSTRUCTION STAGING NECESSARY TO ACCOMMODATE UTILITY RELOCATION OR ADJUSTMENT, AND/OR FOR DELAYS CAUSED BY UTILITY RELOCATION OR ADJUSTMENT

4. THE CONTRACTOR SHALL BE RESPONSIBLE FOR CONTACTING LOCAL AGENCIES MAIN-TAINING SANITARY SEWERS AND WATER MAINS TO VERIFY THE MATERIALS AND METHOD ALLOWED FOR THE ADJUSTMENT OR RELOCATION OF THEIR FACILITIES, IF NECESSARY.

5. THE COST OF MAKING STORM SEWER CONNECTIONS TO EXISTING OR PROPOSED STORM SEWERS OR DRAINAGE STRUCTURES SHALL BE INCLUDED IN THE COST OF THE STORM SEWER BEING CONNECTED.

ALL ABANDONED INVERTS SHALL BE PLUGGED WITH BRICK AND MORTAR TO THE SATISFACTION OF THE ENGINEER. THIS WORK SHALL BE INCLUDED IN THE COST OF THE STRUCTURE BEING REMOVED.

E. TREE AND BUSH REMOVAL AND CLEARING

ALL TREES NOT DESIGNATED FOR REMOVAL SHALL BE PROTECTED UNDER THE PRO-VISIONS OF ARTICLES 201.05 AND 201.11(c) OF THE "STANDARD SPECIFICATIONS".

2. ALL LIMBS, BRANCHES AND OTHER DEBRIS RESULTING FROM THIS WORK SHALL BE DISPOSED OF BY THE CONTRACTOR AT HIS OWN EXPENSE OUTSIDE THE ILIMITS OF THE RICH-OF-WAY.

ALL CLEARING AND REMOVAL OF BUSHES AND TREES UNDER 6" IN DIAMETER WILL BE INCLUDED IN "EARTH EXCAVATION".

F. ROADWAY EXCAVATION AND REMOVAL

1. ALL EXISTING GRANULAR AND BITUMINOUS MATERIALS TO BE REMOVED AND NOT PAID FOR AS A SPECIFIC TIEM SHALL BE CONSIDERED EARTH, AND WILL BE PAID FOR AT THE CONTRACT UNIT PRICE FOR "EARTH EXCANATION." THE CONTRACTOR SHALL HAVE THE OPTION OF REMOVING THE EXISTING BITUMINOUS MATERIAL BY GRINDING OR EXCAVATION. IF THE BITUMINOUS MATERIAL IS REMOVED BY EXCAVATION, IT MAY NOT BE USED IN EMBANKMENT AREAS UNLESS SPECIFICALLY SO AUTHORIZED BY THE REGINEER. BITUMINOUS MATERIAL REMOVED BY GRINDING MAY BE USED AS EMBANKMENT MATERIAL.

THE CONTRACTOR SHALL NOT CROSS COMPLETED BASE COURSE, OR EXISTING PAVEMENT NOT SCHEDULED TO BE REMOVED, WITH CONSTRUCTION EQUIPMENT WHICH MAY DAMAGE THE PAVEMENT.

3. ALL EMBANKMENTS AND SUB-GRADE SHALL BE COMPACTED TO THE SATISFACTION OF THE ENGINEER PRIOR TO THE PLACEMENT OF GRANULAR SUB-BASE OR EMBANKMENT.

4. ALL EXCESS MATERIAL (BROKEN CONCRETE (OTHER THAN FROM PAVEMENT REMOVAL), SEWER PIPE, WASTE ROAD EXCAVATION AND SURPLUS MATERIAL FROM SEWER TRENCHES) SHALL BE LEGALLY DISPOSED OF OUTSIDE THE LIMITS OF THE RIGHT-OF-WAY. IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO SELECT DUMP SITES AND OBTAIN PERMISSION AND ALL NECESSARY PERMITS TO USE SUCH DUMP SITES. PAYMENT FOR THIS WORK SHALL BE INCLUDED IN "EARTH EXCAVATION".

5. ANY EXISTING DRAINAGE FACILITIES, HEADWALLS, FENCES OR OTHER OBSTRUCTIONS WHICH INTERFERE WITH THE PROPOSED IMPROVEMENT (IN THE OPINION OF THE ENGINEER). AND WHICH ARE NOT SHOWN ON THE PLANS, SHALL BE REMOVED. ANY OF THIS MATERIAL CONSIDERED BY THE ENGINEER TO BE SALVAGEABLE SHALL BE STORED WITHIN THE RIGHT-OF-WAY FOR LATER REMOVAL BY THE ASENCY MAINTAINING THE ROADWAY INVOLVED.

G. TRENCH BACKFILL

WHERE TRENCH BACKFILL IS REQUIRED, THE MATERIAL USED SHALL BE COMPACTED AS SPECIFIED IN ARTICLE 550.07 OF THE "STANDARD SPECIFICATIONS" USING METHOD ONE.

H. STORM SEWERS, STRUCTURES AND UTILITIES

THE STATION/OFFSET/ELEVATIONS NOTED FOR ALL DRAINAGE STRUCTURES LOCATED IN THE CURB LINE REFER TO THE POSITION OF THE ADJACENT PROPOSED EDGE OF PAVEMENT. THE CONTRACTOR SHALL BE RESPONSIBLE FOR DETERMINING THE OFFSET NECESSARY FOR EACH STRUCTURE TO SET THE FRAME AND GRATE IN ITS PROPER LOCATION. OFFSETS SHOWN FOR ALL OTHER STRUCTURES ARE TO THE

TOP OF FRAME ("RIM") ELEVATIONS GIVEN ON THE PLANS ARE ONLY TO ASSIST THE CONTRACTOR IN DETERMINING THE APPROXIMATE OVERALL HEIGHT OF EACH STRUCTURE. FRAMES ON ALL NEW STRUCTURES SHALL BE ADJUSTED TO THE FINAL ELEVATIONS OF THE AREAS IN WHICH THEY ARE LOCATED, AS PART OF THE

3. WHEN EXISTING DRAINAGE FACILITIES ARE DISTURBED, THE CONTRACTOR SHALL PROVIDE AND MAINTAIN TEMPORARY OUTLETS AND CONNECTIONS FOR ALL PUBLIC OR PRIVATE DRAINS, SEWERS OR CATCH BASINS. I. BITUMINOUS SURFACE COURSE

BITUMINOUS CONCRETE SURFACE COURSE SHALL NOT BE PLACED UNTIL ALL EARTH EXCAVATION, TOP SOIL PLACEMENT AND BITUMINOUS CONCRETE BINDER COURSE HAVE BEEN COMPLETED TO THE SATISFACTION OF THE ENGINEER.

BITUMINOUS QUANTITIES USED IN DESIGN AND CALCULATIONS ARE BASED ON 112 POUNDS PER INCH THICKNESS PER SQUARE YARD.

EXCAVATION AT ALL DRIVEWAYS WILL BE PAID FOR AS "EARTH EXCAVATION" EXCEPT THAT THE REMOVAL OF CONCRETE PAVEMENT WILL BE PAID FOR AS "DRIVEWAY PAVEMENT REMOVAL" AND THE REMOVAL OF ASPHALT PAVEMENT WILL BE PAID FOR AS "BITUMINOUS DRIVEWAY REMOVAL".
