XX004782 TEMPORARY BITUMINOUS PAVEMENT

Description: This work shall consist of constructing, maintaining, and removing temporary bituminous pavement at the locations shown on the plans or as directed by the Engineer.

Materials: The hot-mix asphalt materials shall be according to Section 1030 of the "Standard Specifications".

General: Temporary bituminous pavement shall consist of 10" of Hot-Mix Asphalt Binder Course constructed and compacted according to Section 355 of the "Standard Specifications". The temporary bituminous pavement shall be placed and compacted in a minimum of two lifts on a prepared sub-grade.

The bituminous mixture shall be shown on the plans.

Article 355.08 of the "Standard Specifications", shall not apply.

The removal of temporary bituminous pavement shall be according to Section 440 of the "Standard Specifications". The removed pavement shall be disposed of outside the right-of-way according to Article 202.03 of the "Standard Specifications".

Method of Measurement: Temporary Bituminous Pavement will be measured for payment in place, and the area computed in square yards.

Basis of Payment: This work will be paid for at the contract unit price per square yard for TEMPORARY BITUMINOUS PAVEMENT. The unit price shall include both placement and removal of the hot-mix asphalt material.
