WINNEBAGO COUNTY SECTION 07-00421-00-BR C.H. 11 (F.A.S. 1045)

<u>REMOVAL OF UNCLASSIFIED MATERIAL.</u> Existing culverts and other unclassified materials shall be removed at the locations shown on the plans or designated by the Engineer. The removed materials shall be disposed of beyond the limits of the right of way in accordance with Article 203.03 of the Standard Specifications, and as directed by the Engineer.

The above work will not be paid for separately, but shall be considered as incidental to the item EARTH EXCAVATION and no additional compensation will be allowed.

EXCAVATION FOR STRUCTURES. This work shall be performed in accordance with Section 502 of the Standard Specifications and as follows:

Excavation required for the construction of the abutments, including excavation for Porous Granular Embankment at the abutments, shall be paid for as STRUCTURE EXCAVATION.

Excavation required for the construction of the Piers will not be paid for as a separate item, and the cost of the excavation shall be considered as included in the contract unit price for CONCRETE STRUCTURES.

STONE RIPRAP. This work shall be performed in accordance with Section 281 of the Standard Specifications and as follows:

Excavation and aggregate bedding will not be paid for as separate items but shall be considered as included in the unit price bid for the Riprap.
