

THE CONTRACTOR WILL NOT BE ALLOWED TO SET UP A YARD OR FIELD OFFICE ON STATE (OR TOLLWAY) PROPERTY WITHOUT WRITTEN PERMISSION FROM THE DEPARTMENT (OR ISTHA)




HMA CONSTRUCTED TEMPORARY RAMP




## TYPICAL ENTRANCE RAMP PAVEMENT MARKINGS



# TYPICAL ENTRANCE/EXIT RAMP COMBINATION PAVEMENT MARKINGS




## TYPICAL EXIT ONLY LANE PAVEMENT MARKINGS




