2. Calculated weight of Structural Steel = 91,840 lbs. (M 270, grade 50) = 14,690 lbs. (M 270, grade 36)

3. No field welding is permitted except as specified in the contract documents.

4. Reinforcement bars shall conform to the requirements of ASTM A 706 Gr 60 (IL Modified). See Special Provisions

5. Reinforcement bars designated (E) shall be epoxy coated.


6. The Inorganic Zinc Rich Primer / Acrylic / Acrylic Paint System shall be used for shop and field painting of new structural steel except where otherwise noted. The color of the final finish coat for all interior steel surfaces shall be gray, Munsell No. 5B 7/1. The color of the final finish coat for the exterior and bottom flange of the fascio beams shall be Interstate Green, Munsell No. 7.5G 4/8. See Special Provision for "Cleaning and Painting New Metal Structures".

7. Layout of slope protection system may be varied in the field to suit ground conditions as directed by the Engineer.

8. The embankment configuration shown shall be the minimum that must be placed and compacted prior to construction of the abutments.

9. The Contractor shall drive test piles to 110% of the nominal required bearing specified in production locations at substructures specified or approved by the Engineer before ordering the remainder of piles.


10. Load carrying components designated "NTR" shall conform to the Supplemental Requirements for Notch Toughness, Zone 2.


