## IDOT PROJECT LABOR AGREEMENT DETERMINATION

Re: FAP Route 705 (IL 122) Resurfacing Project, Contract Number 68C94, Tazewell County

In accordance with the Project Labor Agreement Act (30 ILCS 571), it is recommended that a project labor agreement (PLA) be utilized for the above-captioned Project. This recommendation is based on the considerations indicated below.

- 1) The Project is being awarded and administered by IDOT (i.e., not by another governmental agency).
- 2) The Project is being constructed using state or local funds only (i.e., no federal funds).
- 3) The overall size, scope, sequencing, logistics or other aspects of the Project make it particularly challenging to manage, and use of a PLA is expected to help assure that the construction work is performed properly and efficiently under the circumstances.
- 4) The duration of construction activity on the Project is expected to exceed one construction season (i.e., 110 or more working days), or the nature of the Project results in a heightened need for labor force continuity and stability over a substantial period of time.
- 5) There is a firm construction completion date established for the Project thereby increasing the adverse consequences of any work stoppage or other labor disruption.
- 6) The time required to complete the Project is expected to extend beyond the expiration date of one or more existing collective bargaining agreements covering trades likely to be involved in the Project, thereby increasing the likelihood of work stoppage(s) or other labor disruption(s) during construction of the Project. **See Attachment A.**
- 7) In the absence of a PLA, there is an increased likelihood of jurisdictional disputes among unions or of conflict between unionized and non-unionized workers on the Project that could have a potentially material adverse effect on the time, cost, or quality of work performed on the Project.






### Attachment A

Justification for use of project Labor Agreement on Contract 68C94,  
Tazewell County:

The use of a project Labor Agreement on this project is consistent with all State and Local statutory regulatory requirements.

**Project Description:** This project is located on Illinois Route 122 from Illinois Route 29 to just east of Oak Street in Delavan in Tazewell County. This project consists of Class D patching, cold-in-place recycling (CIR), mill and resurfacing, ADA improvements, curb and gutter removal and replacement, drainage improvements and any other related collateral work necessary to complete the work.

The estimated project cost is \$6.2 million. The contract requires completion of the work in 75 working days.

**Item 6:** The time required to complete the project extends beyond the expiration of one or more existing collective bargaining agreements covering trades likely to be involved in the project. The trades that will be used on this project include but are not limited to those listed below. Trade contracts expiring prior to the anticipated construction completion date are indicated with bold font.

**Item 8:** The project requires cold-in-place recycling of the existing pavement which has weather restrictions.

Weather Limitations. Recycling operations shall be done between May 1st and September 15th, and when the temperature is at least 50°F (10°C) and rising and the forecast for the next 48 hours is above 35°F (2°C). The weather shall not be foggy or rainy. The Engineer may restrict work when the heat index is greater than 100°F (38°C).


Any disruption to the contractor's schedule due to labor issues may result in an increase in duration of the project, including delaying work until then following construction season. This, in turn, could increase the length of time the traffic control or uneven surfaces will be in place including during a winter shutdown. The district desires to minimize the possible delay over the winter to reduce the potential for crashes and to improve safety.
