The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction," adopted January 1, 2007 (and hereinafter referred to as the "Standard Specifications"); the latest edition of the "Illinois Manual on Uniform Traffic Control Devices for Streets and Highways" in effect on the date of invitation for bids, the latest manual for Testing of Materials, the latest edition of the "Illinois Urban Manual" prepared by the U.S. Department of Agriculture Natural Resource Conservation Service in effect on the date of invitation for bids; the latest edition for bids; the "Standard Specifications for Water and Sewer Main Construction in Illinois" in effect on the date of invitation for bids; the "Supplemental Specifications and Recurring Special Provisions" adopted January 1, 2011 as indicated on the check sheet included herein, in effect on the date of invitation for bids, which apply to and govern the construction of Winn Road, Section 07-00012-00-BR, Project Number BRM-8003-(922), Job Number C-91-141-08 in Village of Spring Grove and in case of conflict with any part or parts of said specifications, the said Special Provisions shall take precedence and shall govern.

LOCATION OF PROJECT

Improvements are located on Winn Road (FAU Route 0157) south of the intersection of Winn Road and Main Street (STA 28+00 to 33+38), a total distance of 537.8 feet (0.10 miles), located in Village of Spring Grove, McHenry County, Illinois.

DESCRIPTION OF PROJECT

Work to be performed under this contract consists of the removal and replacement of Winn Road Bridge over Nippersink Creek, and hot-mix asphalt pavement reconstruction, shoulder, shared use path, and guardrail removal and replacement. This work will include, but not be limited to, removal of existing structures, concrete structures, furnishing and erecting precast, prestressed concrete deck beams, concrete superstructure, removal and disposal of unsuitable material, pavement removal, hotmix asphalt pavement reconstruction, hot-mix asphalt shoulders, curb and gutter, erosion control, topsoil furnish and place, seeding, and all incidental and collateral work necessary to complete the project as shown on the plans and described herein.
