GENERAL NOTES

- 1. Fasteners shall be AASHTO M164 Type 1, mechanically galvanized bolts. Bolts ${}^{7}_{8}$ " ϕ , holes ${}^{15}_{16}$ " ϕ , unless otherwise noted.
- 2. Calculated weight of Structural Steel (M270 Grade 50) = 1,394,330 lbs. Calculated weight of Structural Steel (M270 Grade 36) = 18,680 lbs.
- 3. No field welding is permitted except as specified in the contract documents.
- 4. Reinforcement bars shall conform to the requirements of ASTM A 706 Gr 60, See Special Provisions.
- 5. Reinforcement bars designated (E) shall be epoxy coated.
- 6. If the Contractor elects to use cantilever forming brackets on the exterior beams or girders, the brackets shall be placed at the same locations as required for the hardwood blocks in Article 503.06(b) of the Standard Specifications. If additional cantilever forming brackets are required, hardwood blocking shall be wedged between the exterior and first interior beam at each of these additional bracket locations.
- Plan dimensions and details relative to existing plans are subject to nominal construction variations. The Contractor shall field verify existing dimensions and details affecting new construction and make necessary approved adjustments prior to construction or ordering of materials. Such variations shall not be cause for additional compensation for a change in scope of the work, however, the Contractor will be paid for the quantity actually furnished at the unit price bid for the work.
- 8. Bearing seat surfaces shall be constructed or adjusted to their designated elevations within a tolerance of ¹_R inch (0.01 ft.). Adjustment shall be made either by grinding the surface or by shimming the bearings.
- 9. Concrete Sealer shall be applied to the designated areas of the exposed surfaces of backwalls, bridge seats, and front faces of pile caps under abutment deck joints; and all exposed surface areas at piers within 10 ft. of the outer edge of shoulder.
- 10. The existing structural steel coating contains lead. The Contractor shall take appropriate precautions to deal with the presence of lead on this project.
- 11. The Organic Zinc Rich Primer / Epoxy / Urethane Paint System shall be used for painting of new structural steel except where otherwise noted. The entire system shall be shop applied, with the exception that masked off connection surfaces, field installed fasteners and damaged areas shall be touched up in the field. The color of the final finish coat for all interior steel surfaces shall be Gray, Munsell No. 5B 7/1. The color of the final finish coat for the exterior and bottom flange of the fascia beams shall be Reddish Brown, Munsell No. 2.5YR 3/4. See Special Provision for "Cleaning and Painting New Metal Structures".
- 12. The embankment configuration shown shall be the minimum that must be placed and compacted prior to construction of the abutments.
- 13. The concrete for bridge decks finished according to Article 503.16(a) of the Standard Specifications shall be placed and compacted parallel to the skew in uniform increments along centerline of bridge. The machine used for finishing shall be set parallel to the skew for striking off and screeding the concrete.

All drainage system components shall extend parallel to the abutment back wall until they intersect the wingwalls or 2'-0" from the end of the wingwalls when the wings are parallel to the abutment. The pipe shall extend under the wingwall, if necessary, until intersecting the side slopes. The pipes shall drain into concrete headwalls. (See Article 601.05 of the Standard Specifications and Highway Standard 601101).
