SPECIAL PROVISIONS

The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction" adopted April 1, 2016, the latest edition of the "Illinois Manual on Uniform Traffic Control Devices for Streets and Highways", and the Manual of Test Procedures for Materials" in effect on the date of invitation for bids, and the "Supplemental Specifications and Recurring Special Provisions" indicated on the Check Sheet included herein which apply to and govern the construction of Park Road, Section LAKE LE-AQUA-NA 2018, Stephenson County, Contract No. 46906 and in case of conflict with any part or parts of said specifications, the said Special Provisions shall take precedence and shall govern.

LOCATION OF PROJECT

The project limits are within the Lake Le-Aqua-Na State Park, located at 854 North Lake Road, Lena, IL in Stephenson County.

DESCRIPTION

This proposed improvement consists of the asphalt resurfacing and reconstruction of the park roads and parking lots, removal and replacement of culverts, removal and replacement of some electrical components, pavement marking, ADA sidewalk/ramp upgrades, and all other necessary work to complete the project within the Lake Le-Aqua-Na State Park in Stephenson County.

WORKING DAYS (BDE)

Effective: January 1, 2002

The Contractor shall complete the work within **95** working days.
