ENGINEER'S FIELD OFFICE TYPE A (D1)

Effective: January 1, 2022

Revise the first paragraph of Article 670.02 to read:

670.02 Engineer's Field Office Type A (D1). Type A (D1) field offices shall have a ceiling height of not less than 7 feet and a floor space of not less than 1000 square feet with a minimum of two separate offices. The office shall also have a separate storage room capable of being locked for the storage of the nuclear measuring devices. The office shall be provided with sufficient heat, natural and artificial light, and air conditioning. Doors and windows shall be equipped with locks approved by the Engineer.

Add the following to Article 670.07 Basis of Payment.

The building or buildings, fully equipped, will be paid for at the contract unit price per calendar month or fraction thereof for ENGINEER'S FIELD OFFICE, TYPE A (D1).

CONTRACTOR COOPERATION

It is anticipated that this contract will be constructed simultaneously with other roadway projects in the same area. The projects that may be concurrent with this project are:

62P69 – Foster Ave Over North Branch Chicago River / Cook County, S.N. 016-0249 & S.N. 016-0250. Bridge Deck Overlay and Bridge Joint Repair.

September 2024 letting, Construction expected to begin in April of 2025

The IDOT Contractor for this contract shall schedule her/ his work to minimize any conflicts that may arise between contracts, as specified in Article 105.08 of the Standard Specifications. No additional compensation will be allowed for delays or inconveniences resulting from activities of other contractors.

RESTRICTIVE START DATE

No Bridge painting work will be permitted prior to April 13, 2026. Temporary lane closures for any advance work may be allowed at the discretion of the Engineer.
