MAINTENANCE OF TRAFFIC GENERAL NOTES

- 1. THE CONTRACTOR SHALL PROVIDE AND MAINTAIN A MINIMUM OF TWO 11'THROUGH TRAFFIC LANES IN EACH DIRECTION ON IL ROUTE 2 AND ONE 12' LANE IN EACH DIRECTION ON US ROUTE 20, EXCEPT AS OTHERWISE INDICATED ON THE PLANS, OFF-PEAK PERIOD LANE CLOSURES WILL BE ALLOWED FOR CONSTRUCTION ACTIVITY ONLY AS APPROVED BY THE ENGINEER, SEE SPECIAL PROVISIONS FOR ALLOWABLE OFF-PEAK PERIOD LANE CLOSURE TIMES.
- 2. THE CONTRACTOR SHALL PROVIDE ALL SIGNS, VERTICAL PANELS, TYPE III BARRICADES, CHANNELIZATION DRUMS, TYPE II BARRICADES, ALL TEMPORARY CONCRETE BARRIERS AND PROTECTION NECESSARY FOR WORK ZONE TRAFFIC CONTROL AND PROTECTION, OR AS DIRECTED BY THE ENGINEER.
- 3. THE CONTRACTOR SHALL INSTALL AND MAINTAIN PROPOSED AND TEMPORARY DRAINAGE SYSTEMS, AND EROSION CONTROL MEASURES DURING STAGE CONSTRUCTION THROUGHOUT THE DURATION OF THE PROJECT. THIS WORK SHALL BE INCLUDED IN THE COST OF THE PAY ITEMS ASSOCIATED WITH THE APPLICABLE DRAINAGE SYSTEMS AND EROSION CONTROL MEASURES. SEE EROSION CONTROL PLANS.
- 4. THE CONTRACTOR SHALL USE TEMPORARY PAVEMENT MARKING ON SURFACES TO BE REMOVED AND IN AREAS THAT DO NOT CONFLICT WITH OTHER STAGES. DURING ALL WINTER STAGING MONTHS

 (NOVEMBER 1 APRIL 1) PAVEMENT MARKINGS SHALL BE PAINT. THE PLACEMENT AND REMOVAL OF PAVEMENT MARKINGS FOR WINTER MONTHS SHALL BE PAID FOR AT THE CONTRACT UNIT COST FOR TEMPOARY PAVEMENT MARKING OF THE SIZE SPECIFIED ON THE PLANS AND PAVEMENT MARKING REMOVAL-WATER BLASTING.
- 5. 4 INCH SOLID WHITE PAVEMENT MARKING LINES SHALL BE USED TO DEFINE THE EDGE LINE WHERE CURB AND GUTTER DOES NOT EXIST.
- 6. 4 INCH SOLID DOUBLE YELLOW PAVEMENT MARKING LINES ARE TO BE USED TO SEPARATE OPPOSING TRAFFIC LANES.
- 7. ALL DOUBLE YELLOW CENTERLINE MARKING LINES SHALL BE SPACED AT 12 INCHES CENTER TO CENTER.
- 8. 6 INCH SOLID WHITE PAVEMENT MARKING LINES ARE TO BE USED TO DEFINE TURN LANES.
- 9. 12 INCH SOLID YELLOW PAVEMENT MARKING LINES ARE TO BE USED FOR TEMPORARY FLUSH MEDIAN DIAGONAL LINES AT LOCATIONS AS SHOWN ON THE PLANS.
- 10. 24 INCH SOLID WHITE PAVEMENT MARKING LINES ARE TO BE USED FOR STOP BARS.
- 11. ALL DRUMS, VERTICAL PANELS, AND TYPE II BARRICADES (IF REQUIRED) SHALL BE EQUIPPED WITH MONO-DIRECTIONAL STEADY BURNING LIGHTS ON MULTILANE ROADWAYS, WHILE BI-DIRECTIONAL LIGHTS ARE REQUIRED ON ALL, TWO-WAY, TWO-LANE ROADWAYS.
- 12. ALL DRUMS, VERTICAL PANELS, AND TYPE II BARRICADES SHALL BE SPACED AT 40 FEET CENTER TO CENTER THROUGHOUT THE WORK ZONE, EXCEPT IN TAPER AREAS, GORE AREAS, AND ALONG CORNER RADII, WHERE THEY SHALL BE SPACED AT 20 FEET CENTER TO CENTER EXCEPT AS OTHERWISE INDICATED ON THE PLANS.
- 13. TYPE II BARRICADES SHALL BE USED IN LIEU OF DRUMS IN LOCATIONS WHERE TYPE II MUST BE PLACED IN EXCAVATED AREAS DUE TO LIMITED SPACE. THESE BARICADES SHALL HAVE LEG EXTENSIONS INSTALLED SUCH THAT THE TOP OF THE BARRICADE IS IN COMPLIANCE WITH IDOT HIGHWAY STANDARD 701901. DRUMS AND BARRICADES SHALL NOT BE PLACED TOGETHER WITHIN AN INDIVIDUAL RUN OF DEVICES.
- 14. TEMPORARY CONCRETE BARRIERS SHALL BE EQUIPPED WITH TYPE "C" REFLECTORS, IN ACCORDANCE WITH HIGHWAY STANDARD 704011 SPACED AT 25' CENTERS.
- 15. ALL CONSTRUCTION WARNING SIGNS SHALL BE BLACK LEGEND ON ORANGE BACKGROUND.
- 16. ALL CONSTRUCTION WARNING SIGN DIMENSIONS SHALL BE 48" X 48", EXCEPT AS OTHERWISE STATED ON THE PLANS.

- 17. ALL "ROAD CONSTRUCTION AHEAD" WARNING SIGNS SHALL BE EQUIPPED WITH HIGH INTENSITY MONO-DIRECTIONAL FLASHING LIGHTS.
- 18. THE CONTRACTOR SHALL INSTALL AND COVER ALL TEMPORARY SIGNING BEFORE EXISTING SIGNS ARE REMOVED. THE CONTRACTOR SHALL RELOCATE EXISTING SIGNS AS INDICATED ON THE PLANS.
- 19. THE CONTRACTOR SHALL INSTALL AND COVER ALL PERMANENT SIGNING BEFORE TEMPORARY SIGNS ARE REMOVED. THE COST OF THIS WORK SHALL BE INCLUDED IN THE COST FOR SIGN PANEL, OF THE TYPE SPECIFIED.
- 20. ALL EXISTING GUIDE SIGNS (1.0. STREET NAME SIGNS, ADVANCE STREET NAME SIGNS, ROUTE MARKERS, ETC.) SHALL BE MAINTAINED AND VISIBLE TO TRAFFIC DURING CONSTRUCTION.
- 21. EXISTING, TEMPORARY AND PROPOSED TRAFFIC/GUIDE SIGNS IN CONFLICT WITH STAGING SHALL BE COVERED AS INDICATED ON THE MAINTENANCE OF TRAFFIC PLANS AND/OR AS DIRECTED BY THE ENGINEER. THE COST OF THIS WORK SHALL BE CONSIDERED INCLUDED IN THE CONTRACT COST FOR TRAFFIC CONTROL AND PROTECTION, (SPECIAL).
- 22. THE FABRICATION, INSTALLATION, MAINTENANCE AND REMOVAL OF TEMPORARY GUIDE SIGNS, TEMPORARY SIGN PANELS AND BLANK-OUT PANELS, AS SHOWN IN THE MAINTENANCE OF TRAFFIC SIGN PANEL DETAILS AND PLANS WILL BE INCLUDED IN THE COST FOR TRAFFIC CONTROL AND PROTECTION, (SPECIAL). THE RELOCATION OF THESE TEMPORARY PANELS/SIGNS FOR SUBSEQUENT STAGES SHALL ALSO BE CONSIDERED IN THE COST FOR TRAFFIC CONTROL AND PROTECTION, (SPECIAL).
- 23. DIRECTION INDICATOR BARRICADES SHALL BE USED AT LANE CLOSURE TAPER LOCATIONS FOR ROADWAYS WITH SPEEDS GREATER THAN OR EQUAL TO 45 MPH OR AS OTHERWISE DIRECTED BY THE ENGINEER.
- 24. AT THE END OF EACH WORK DAY, THE CONTRACTOR SHALL BACKFILL OR COVER ALL TRENCHES AND OPEN EXCAVATION HOLES FOR PROPOSED STORM SEWER, DRAINAGE STRUCTURES, AND WATER MAINS IN ORDER TO PROVIDE A SAFE CONDITION FOR MOTORISTS AND THE PUBLIC DURING NON-WORKING HOURS. THE COST OF THIS WORK SHALL BE INCLUDED IN THE COST FOR TRAFFIC CONTROL AND PROTECTION (SPECIAL).
- 25. TEMPORARY CONCRETE BARRIER SHALL BE CONTINUOUSLY PINNED TO THE PAVEMENT WHEREVER A 37 INCH CLEAR ZONE (FREE OF DROP-OFFS, FIXED OBJECTS, OR OTHER OBSTACLES) CANNOT BE PROVIDED FOR BEHIND THE BARRIER. THIS WORK SHALL BE PAID FOR SEPARATELY AT THE CONTRACT UNIT PRICE FOR PINNING TEMPORARY CONCRETE BARRIER. LOCATIONS FOR TEMPORARY CONCRETE BARRIER PINNING ARE SHOWN IN THE SCHEDULE OF QUANTITIES.
- 26. TEMPORARY TRAFFIC SIGNALS WILL BE CONSTRUCTED AT THE INTERSECTIONS SHOWN ON THE PLANS AND PAID FOR AS TEMPORARY TRAFFIC SIGNAL INSTALLATION, PER EACH INTERSECTION. TEMPORARY INTERSECTION SIGNALIZATION SHALL BE ADJUSTED TO ACCOMMODATE THE VARIOUS STAGES OF CONSTRUCTION SHOWN ON THE PLANS, AT NO ADDITIONAL COST TO THE CONTRACT.
- 27. THE ENGINEER SHALL BE INFORMED 48 HOURS IN ADVANCE OF ANY CHANGE TO THE MAINTENANCE OF TRAFFIC PLANS ALL CHANGES TO THE MAINTENANCE OF TRAFFIC PLANS SHALL BE APPROVED BY TRAFFIC.
- 28. EXISTING OR TEMPORARY PAVEMENT MARKINGS REMOVED AS A RESULT OF PAVEMENT REMOVAL WILL NOT BE PAID FOR SEPARATELY.
- 29. BARRIER WALL OFFSETS SHOWN ARE TO THE CENTER OF THE WALL.

PREAMBLE TO THE MAINTENANCE OF TRAFFIC

FOR THE REFERENCES MADE TO ILLINOIS ROUTE 2, LANE 1 IS THE THROUGH LANE ALONG THE MEDIAN, LANE 2 IS THE MIDDLE LANE AND LANE 3 IS THE OUTSIDE LANE.

OFF PEAK HOURS ARE AS DEFINED IN "KEEPING THE EXPRESSWAY OPEN TO TRAFFIC" AND "KEEPING ARTERIAL ROADWAYS OPEN TO TRAFFIC" SPECIAL PROVISIONS.
