"The seed quantities indicated per acre (hectare) for Prairie Grass Seed in Classes 3, 3A, 4, 4A, 6, and 6A in Article 250.07 shall be the amounts of pure, live seed per acre (hectare) for each species listed."

SUBCONTRACTOR MOBILIZATION PAYMENTS (BDE)

Effective: April 2, 2005

To account for the preparatory work and operations necessary for the movement of subcontractor personnel, equipment, supplies, and incidentals to the project site and for all other work or operations that must be performed or costs incurred when beginning work approved for subcontracting in accordance with Article 108.01 of the Standard Specifications, the Contractor shall make a mobilization payment to each subcontractor.

This mobilization payment shall be made at least 14 days prior to the subcontractor starting work. The amount paid shall be equal to 3 percent of the amount of the subcontract reported on form BC 260A submitted for the approval of the subcontractor's work.

This provision shall be incorporated directly or by reference into each subcontract approved by the Department.

TEMPORARY CONSTRUCTION LICENSE (LAKE COUNTY FOREST PRESERVE)

The Contractor will be required to obtain a temporary construction license from the Lake County Forest Preserve in accordance with Article 107.04 of the Standard Specifications prior to accessing the log home site through the Lake County Forest Preserve right of way. Approximately 800 feet of the hiking and recreation path lies within the Lake County Forest Preserve property.

The temporary construction license requirements are as follows:

- •\$500.00 application fee
- Bond in the amount of \$10,000.00 with the Lake County Forest Preserve
- Certificate of insurance naming the Forest Preserve District as an additional insured.

The Contractor will furnish a copy of the authorized construction license to the Engineer.
