SPECIAL PROVISIONS

The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction," adopted January 1, 2007, the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways," and the "Manual of Test Procedures for Materials" in effect on the date of invitation for bids, and the Supplemental Specifications and Recurring Special Provisions indicated on the Check Sheet included herein which apply to and govern the construction of FAP Route 337 (IL 22); Section 2007-014 DM; Lake & DuPage Counties; and in case of conflict with any part or parts of said Specifications, the said Special Provisions shall take precedence and shall govern.

LOCATION OF IMPROVEMENT

In addition to the IL 22 site, there are an additional two sites for this demolition project.

Site Location 1 is on IL 22 (Half Day Road) between US 45 / IL 21 (Milwaukee Avenue) and Interstate 94 (Tri-State Tollway) within the Village of Lincolnshire in Lake County. The addresses are 14736 Half Day Road and 14746 Half Day Road.

Site Location 2 is on York Court near Midlothian Road within the Village of Mundelein in Lake County. The address is 1608 York Court.

Site Location 3 is on IL 53 between IL 56 (Tamarack Drive) and Osage Drive (south of IL 56) within the Village of Glen Ellyn in DuPage County. The address is 22W376 IL Route 53, Glen Ellyn, IL 60137.

DESCRIPTION OF IMPROVEMENT

This is a building demolition contract in which the work to be performed under this contract consists of the demolition of two log buildings, one garage, one former out building, two single family brick and frames houses, two sheds with all their foundations to their entirety including the basements in addition to all incidental and collateral work necessary to complete the improvement as shown in the plans and described herein.
