GENERAL NOTES

- 1. BEFORE STARTING ANY EXCAVATION, THE CONTRACTOR SHALL CALL "JULIE" AT (800) 892-0123 OR 811 FOR FIELD LOCATIONS OF BURIED ELECTRIC, TELEPHONE, AND GAS FACILITIES. (48 HOUR NOTIFICATION REQUIRED)
- THE CONTRACTOR SHALL COORDINATE DEMOLITION ACTIVITIES WITH UTILITY COMPANIES AND THE CITY OF CREST HILL.
- THE CONTRACTOR WILL NOT BE ALLOWED TO SET UP A YARD OR FIELD OFFICE ON STATE PROPERTY WITHOUT THE WRITTEN PERMISSION OF THE DEPARTMENT.
- 4. THE CONTRACTOR SHALL CONTACT THE DISTRICT ONE ARTERIAL TRAFFIC CONTROL SUPERVISOR AT (847) TOS-4470 A MINIMUM OF 72 HOURS IN ADVANCE OF BEGINNING, WORK.
- IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO VERIFY ALL DIMENSIONS AND CONDITIONS EXISTING IN THE FIELD PRIOR TO CONSTRUCTION AND ORDERING OF MATERIALS.
- 6. DO NOT SCALE PLANS FOR CONSTRUCTION DIMENSIONS.
- T. THE CONTRACTOR SHALL BE REQUIRED TO PROVIDE ACCESS TO ABUTTING PROPERTY AT ALL TIMES DURING THE CONSTRUCTION OF THIS PROJECT.
- 8. THE CONTRACTOR WILL BE RESPONSIBLE FOR OBTAINING A DEMOLITION PERMIT FROM THE CITY OF CREST HILL.
- 9. ALL PERMIT FEES FOR THE DISCONNECTION OF UTILITIES SHALL BE INCLUDED IN THE UNIT PRICE FOR BUILDING REMOVAL.
- TRAFFIC CONTROL SHALL BE INCLUDED IN THE UNIT PRICE FOR BUILDING REMOVAL AND DEBRIS REMOVAL, EXCEPT FOR TEMPORARY INFORMATION SIGNING.
- 11. DUST CONTROL FOR THE SITE SHALL BE IN ACCORDANCE TO ARTICLE 107.36 OF THE STANDARD SPECIFICATIONS FOR ROAD AND BRIDGE CONSTRUCTION, AND SHALL BE INCLUDED IN THE UNIT PRICE FOR BUILDING REMOVAL.
- 12. FULL DEPTH SAWCUT OF REMOVAL ITEMS AS NOTED ON THE PLANS, SPECIFIED IN THE STANDARD SPECIFICATIONS, OR AS REQUIRED BY THE RESIDENT ENGINEER SHALL BE INCLUDED IN THE COST OF THE ITEM BEING REMOVED.
- 13. BACKFILL USED FOR ANY HOLES, SUCH AS BASEMENT, SHALL BE WITH POROUS GRANULAR EMBANKMENT AND SHALL BE INCLUDED IN THE UNIT PRICE FOR BUILDING REMOVAL.
- 14. THE REMOVAL AND DISPOSAL OF ALL DEBRIS AND / OR OBJECTS, INCLUDING LIGHT POLES AND ANY OTHER STRUCTURES AND THEIR FOUNDATIONS THAT ARE NOT PART OF THE BUILDING REMOVAL WITHIN THE CONSTRUCTION LIMITS SHALL BE INCLUDED IN THE UNIT PRICE FOR DEBRIS REMOVAL.
- 15. THE REMOVAL AND DISPOSAL OF SHRUBS, BRUSH, SELECTED TREES UP TO SIX (6) INCHES IN DIAMETER AND STUMPS SHALL BE INCLUDED IN THE UNIT PRICE FOR DEBRIS REMOVAL.
- THE CONTRACTOR SHALL ENSURE THAT THE NORTH, SOUTH AND WEST BASEMENT FOUNDATION WALLS REMAIN INTACT ONLY TO BE REMOVED DOWN TO A PLANE 2 FT BELOW THE FINAL CRADE IN THE AREA AS SHOWN IN THE PLANS. THE EAST BASEMENT FOUNDATION WALL THAT RUNS PARALLEL TO THE EXISTING CONCRETE WALK, STEPS AND RETAINING WALL SHALL ALSO REMAIN INTACT ONLY TO BE REMOVED DOWN TO A PLANE 2 FT BELOW THE FINAL GRADE IN THE AREA AS SHOWN IN THE PLANS. THE CONTRACTOR SHALL TAKE THE APPROPRIATE PRECAUTIONS TO ENSURE THAT THE CONCRETE WALK, STEPS AND RETAINING WALL TO REMAIN ARE NOT DAMAGED DURING THE ENTIRE BUILDING REMOVAL OPERATION. IF DAMAGED, THE ITEM OR ITEMS SHALL BE REPAIRED OR REPLACED AT THE CONTRACTOR'S EXPENSE TO THE SATISFACTION OF THE ENGINEER.
