a. A Description of the soil sample points and how they were determined to be sufficient in number and appropriately located 35 Ill. Adm. Code 1100.610(a)]:

Obtained 14 samples (S-1 to S-14) & samples S-3, 4, 10 & 11 were selected for chemical laboratory testing. Materials certified herewith as CCDD material must be free of rebar, garbage, odors, etc. & any said materials must be segregated from CCDD materials & disposed of in other legal means. Restricted to disposal in an MSA, not including the City of Chicago.

b. Analytical soil testing results to show that soil chemical constituents comply with the maximum allowable concentrations established pursuant to 35 Ill. Adm. Code Part 1100, Subpart F and that the soil pH is within the range of 6.25 to 9.0, including the documentation of chain of custody control, a copy of the lab analysis; the accreditation status of the laboratory performing the analysis; and certification by an authorized agent of the laboratory that the analysis has been performed in accordance with the Agency's rules for the accreditation of environmental and the scope of the accreditation [35 Ill. Adm. Code 1100.201(g), 1100.205(a), 1100.610]:

SEECO screened for volatile organics using a Photo Ionization Detector. No readings indicated the presence of volatile organics associated with contamination at the locations tested. Laboratory analysis were within the MAC range for disposal in an MSA, not including City of Chicago (results attached). Note samples S-13 & S-14 were taken beyond project limits & are not applicable


